JOINT PROCEDURE ORDER No. 02/2023

Sub: -Physical check of Stations using approved ESP/SIP/SWRD/SWR for actual provision at Stations.

Ref: - VC on Review Meeting with Zonal Railways at Highest level dated 03.11.2023.

During referred VC at Highest Level, it was noted that physical check of all Stations has to be done at appropriate Level to see that layout and actual provisions at Stations are same as that in approved ESP/SIP/SWRD/SWR or not. In case of any variation, either modification to be done in the field or concerned documents to be altered.

In this regard, a Joint team of Jr Scale officers for Major/Big Stations and Sr. Supervisors for Small/Road side Stations is to be formed by divisions and the team should be assigned the task of physical check and its tally with approved documents. The team should visit the Stations with approved plans/documents and check the status within a period of 30 days from issue of this JPO.

The team nomination with the approval of DRM to be done as under: -

Major/Big Stations - Sectional AEN/ASTE/AEE(TRD)/AOM or Station Manager of the Station.

Small/Road Side Station- Sectional SE or SSE (P. Way) /SE or SSE (S&T)/SE or SSE(TRD) /Sectional TI or Station Manager.

After check of each & every station of the divisions, a Joint report has to be prepared by the Officials visiting the Stations, indicating variations from approved plan/documents. These may be in regard to CSL of Lines/PF Provision/Level of PF/Signaling changes or route not given/TRD installation and infringements/Provision of Fouling marks/Calling on Boards/Visibility of signals with OHE etc. /visibility of OHE posts/Gradients/etc. This list is not exhaustive and any provision which is missing or may be necessary, be pointed out along with the Good & Bad Practices of the Station if any. Accordingly, how these can be made good, should also be suggested.

Based on the report, immediate action should be taken by divisions to make good the deficiencies.

ADRM/Infra will be the nodal officer for this special work and he will monitor the exercise and coordinate with HQs for any assistance if needed.

Above exercise to be done at least once in every year so that chances of variation at site from approved plans/documents be eliminated.
