Terms and condition for appointment of Station Ticket Booking Agent.

1. Eligibility criteria Documents to be submitted along with application

- a. Applicant should not be under 18 yrs. of age as on the date of notification published in the newspaper. for age proof, school certificate issued from State/Central Board of education or any other relevant documents should be submitted.
- b. Applicant should be at least Class 10th (X) pass. In proof marksheet/School Certificate issued from State/Central Board of Education should be submitted.
- c. The applicant should be a resident of the local district in which the station is located where STBA is proposed to be engaged. (Resident Certificate issued by competent authority should be submitted with application)
- d. The selected applicant will also have to produce a current character certificate issued by the police station serving his/her locality that he/her has no criminal record & no criminal case is pending against him/her. (The Character Certificate should not be more than 6 months old submitted with application.)
- e. Applicant is required to deposit Earnest Money amounting to Rs.2,000/ for (NSG-6 category station) and Rs.5000/- for (NSG-5 category station) along with application, Demand draft should be issued from State Bank of India or any Nationalized Bank in favour of FA & CAO, East Central Railway, Hajipur payable at Patna.

Other term and conditions

- 2. STBA and his/her nominated agent should not be ex-Railway staff who has been removed or dismissed from service on the grounds of doubtful integrity. An undertaking is to be submitted in this regard by the applicant.
- 3. Applicant shall give a declaration that he/she has not been engaged as STBA at any other station.
- 4. Successful applicant should deposit Rs. 10,000/- for NSG 6 & Rs. 25,000/- for NSG 5 category stations as refundable security deposit. The security deposit amount should be deposited in the form of Fixed Deposit or Money Receipt (for a period of 6 Years) issued from State Bank of India or any Nationalized Bank in favour of FA & CAO, East Central Railway, Hajipur.
- 5. The security deposit can be forfeited if the successful applicant does not start the work within 15 days of award letter.
- **6.** The EMD of those applicants, who are not selected, will be refunded within a reasonable time but railway will not be liable to pay any interest on the EMD while in its possession.
- Application not accompanied with the prescribed Earnest Money will be summarily rejected and no correspondence in this regard shall be entertained.
- 8. Applicant should affix a latest passport size photograph with application. Only one applicant will be engaged as STBA at only one station. While furnishing bid/application, applicant shall give a declaration that he/she has not been engaged as STBA at any other station.
- 9. STBA will issue tickets from the existing Booking counter at the station.
- 10. STBA will have to submit the accountal of Sale to Station Master on daily basis along with value of Tickets sold.
- 11. STBA will have to execute an agreement with Rly. Administration within 15 days of Award letter and will have to conduct functioning of STBA as per clauses laid there in.
- 12. Appointment of STBA will not confer any right on the person for employment in Railway. The appointment is purely contractual in nature and no facilities viz. absorption in Rly. Service, regularization of service, bonus, Rly. Pass facilities etc. shall accrue to the STBA.

13. The appointment of STBA is purely contractual in nature and it can be terminated by either side on Ten days' notice.

14. Commission Payable: -

Out of the applicants fulfilling the eligibility conditions, the candidate (s) who opts for the lowest commission (on the 3rd slab) will be selected for appointment. In case of more than one applicant quotes the same rate, the selection will be based on the draw of lots in a transparent manner in public.

- 15. The candidate who opts for least commission (In Slab 3) on monthly sales turnover, shall be engaged as an STBA.
- 16. The commission shall be paid from the station earning.
- 17. The commission shall be paid on the amount credited to Railway's account. In case of concessional tickets, the commission shall be calculated on the actual fare collected by the Railways.
- 18. The cost of hardware & software (including maintenance), electricity and hiring of channel will be borne by the Railways. The space will also be provided by the Railway free of cost.
- 19. STBA, however, if he so desires, may nominate additional person for sale of tickets. Additional number of persons which can be nominated shall be decided by Sr. DCM/DCM based upon the quantum of ticket sale at the station.
- 20. Only one STBA will be appointed at each station. STBA shall not sublet/assign or transfer the rights or obligations arising out of the agreement. In case of death of the agent, his/her legal heir(s) will be allowed as STBA for the unexpired period of the agreement by the competent authority.
- 21. The STBA will deposit the cash collected through sale of tickets, to Station Master/Assistant Station Master on duty on 8 hourly shift basis prevalent on that station.
- 22. If the ticketing activity stops due to non-availability of STBA or due to his/her negligence resulting in non-functioning of equipment, penalty equal to the average daily turnover from sale of UTS tickets from that location, subject to a minimum of Rs. 2000/- per day shall be imposed. Penalty upto Rs.500/- may be imposed against established public complaint regarding the functioning of STBA.
- 23. Both the STBA and the additional person nominated by him to sell tickets shall be issued a photo identity card by the concerned Division and their names (s) will also be displayed on a notice Board at the station premises.
- 24. The disbursement of unreserved tickets by STBA will be governed by the timings as decided by the concerned Railway, keeping in view the local conditions.
- 25. STBA will be authorized to issue cash tickets only. The STBA operator shall be allowed to sell all types of non-concessional unreserved tickets issued through UTS including platform tickets and season tickets. Renewal of season ticket and issue of senior citizen concessional tickets shall also be permitted. All other concessional tickets requiring documentary proof before issue of tickets, can also be issued by STBA only when endorsed and permitted by the SM/ASM concerned, which shall be done prior to the sale of such concessional tickets.
- 26. The facility of 'NI' (non- issued) will be available to the STBA only when authorized/endorsed by the concerned SM/ASM.
- 27. Cancellation of ticket: The facility of cancellation of ticket may be extended to STBA only when authorized/endorsed by concerned SM/ASM.

- 28. The Railway officer In-charge of the station i.e., SM/ASM will be responsible for the safe custody of the ticket rolls and it will be his duty to daily hand over/take over the ticket roll from the STBA. Proper record of ticket rolls issued to the STBA will be maintained at stations.
- 29. Shift summary and daily summary of transaction details done by STBA shall be extracted through UTS and the STBA should deposit the cash accordingly to the Station Master/ASM at the end of the shift/day.
- 30. A consolidated statement of ticket rolls supplied and details of tickets sold by STBA will be submitted by Station Master/Manager or any other nominated officer to DCM/Sr.DCM every month.
- 31. Each side can terminate the agreement without assigning reasons by giving a notice of 30 days. However, in case of any fraud/criminal case, Railway shall be at liberty to terminate the contract without giving any prior notice.
- 32. Zonal Railways will have powers to prescribed working guidelines within the framework of the scheme.


