# "Walk-in-Interview" for Engagement of Contract Medical Practitioner (CMP) GDMO/Specialist Doctors on Contract Basis,

- "Walk- in -Interview" will be conducted by Samastipur Division/East Central Railway for engagement of full time Specialist and GDMO for Railway Hospital/Samastipur Division of East Central Railway and for Health Unit/Banmankhi. Willing Doctors who fulfill the qualification/eligibility criteria specified below may apply for the above engagement. The engagement will be purely on contract basis for the period of one year or till the post filled by regular Doctors selected from UPSC or posted by transfer by cadre controlling officer or validity of the scheme is available, whichever is earlier.
- 2. Specialists Doctors & GDMO (Full time).

## (B) (i) Qualification for Specialist/GDMO :-

- (a) Degree/Diploma in corresponding SPECIALTY mentioned above in remarks column.
- (b) Registered with Medical Council of India/Medical Council of State.
- (c) Preference will also be given to those candidates who have experience in Govt. or reputed Private Hospitals

## (ii) Remuneration for Specialists-

Rs.95, 000/ (Rupees Ninety Five Thousand only) for the 1<sup>st</sup> year, Rs. 105,000/ (Rupees One Lakh Five Thousand only) per month for 2<sup>ad</sup> years & onwards, if Railway accommodation not provided. If Railway accommodation is provided deduction will be made from the monthly remuneration equivalent to House Rent Allowance payable on minimum pay Senior Scale Officer (Level -11 in 7<sup>th</sup> CPC) and fixed license fee for accommodation.

#### (iii) Remuneration for GDMO

Rs. 75,000/ (Rupees Seventy Five Thousand only) per month, if Railway accommodation is not provided, if Railway accommodation is provided, deduction will be made from the monthly remuneration equivalent to House Rent Allowance payable on minimum pay to Junior Scale Officer (Level-10 in 7<sup>th</sup> CPC) and fixed license fee for accommodation.

3. Age limit: -Not exceeding 53 years as on 08.12.2023 for both i.e. Specialist & General Duty Doctors. Which is relax able by 05 (five) years for candidates belonging to SC/ST community & 03 (three) years for OBC as the case may be.

- 5. Retired IRHS officers, Retired Government Medical Officers of State Government and Central Government may also apply against above vacancies. The condition will be as under:-
- (i) Age: Not exceeding 67 years as on 08.12.2023.
- (ii) Qualification Degree/Diploma in corresponding specialty mentioned in remarks column above for Specialist, the minimum qualification required is MBBS.
- (iii) Remuneration Fixed remuneration of Rs. 75,000/ (Seventy five thousand only) per month for GDMO & Rs. 95,000/-(Ninety five thousands only) per month for Specialist subject to condition that remuneration + pension should not exceed the last pay drawn by retired doctors.
- 6. How to apply:- Candidates intending to join as Contract Medical Practitioner (CMP) should apply on prescribed format (enclosed) and submit the same up to 10.30 AM on the date of interview at venue along with self-attested photocopies of following documents and attend the "Walk in-Interview" with original certificates mentioned below:-

- (iii) Proof of registration in Indian Medical Council/Medical Council of State.
- (iv) Proof of caste in case of SC/ST & non-creamy layer certificate in case of OBC Candidates. (Only on prescribed format for Central Government will be accepted in case of OBC).
- (v) Mark sheet (s) of relevant qualification(s).
- (vi) 04 (four) copies of recent color passport size photograph with self signature.
- (vii) Original Pension Payment Order book & self-attested copy of the same in case of Retired Doctor.
- (viii) Aadhar Card.

## 7. General Conditions and other facilities:-

- (a) In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
- (b) Railway administration has legitimate right to transfer the engaged CMP(s) anywhere over E.C.Railway in case of administrative exigency.
- (c) One set of 1<sup>st</sup> class complimentary pass for self and family shall be issued during each contract period after completion of three months of regular contract services. Contract Medical Practitioner can avail free medical treatment on E.C. Railway Hospital for self only.
- (d) No TA/DA will be paid to the candidates for attending the interview.
- (e) Selected candidates will be posted at Divisional Hospital & Health Unit of Samastipur division.
- (f) CMP will have no right of posting against regular vacant post or transfer at his own request.
- (g) CMP is not being allowed private practice after sanction of contract.
- (h) The candidates working in any Medical Organization/State Govt. should submit their applications through proper channel with "No Objection Certificate".
- (i) There may be change in numbers of vacancies and place of posting as specified above depending upon administrative requirement. Offer of posting will be made on the basis of availability of vacancies at the time of engagement.
- (j) Posts indicated herein may be kept unfilled at the discretion of Railway administration.
- (k) During the validity of the contract, the CMP will be a liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. Contract shall also be terminated if the CMP is found to mentally or physically incapacitate.

(l) Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service. The service rendered as CMP will not confer the right to take wattage for regular selection through UPSC and also will not confer any right for regularization or absorption.

(m) If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to a fresh entrant to Group 'A' Junior Scale/Sr. Scale and license fee of the Railway accommodation will be deducted from the monthly

remuneration payable to the Contract Medical Practitioner

(n) Offer of engagement will be issued in favor of selected candidates. The candidates should report within 15 days from the date of issue offer letter. For candidates not reporting within stipulated time, offer may be cancelled.

- (o) Contract of the CMPs can be terminated by the Railway at any time during the contract period by giving 15 days' notice without assigning any reason as per the terms and condition laid down by Rly.
