**No. ECR/Safety/Red Bulletin – NOV., 23-24**

Date: 04.12.2023

### **1. Major irregularities noticed during inspections: -**

- (A) At Shivpur (SVPO) station in DHN division, it was observed that CORRESPONDENCE TEST was not done on 15.10.23 after reconnection of PF no. 56/A& B, 61/A& B and 62/A& B. SMs must ensure that correspondence test is done before accepting Reconnection Memo.
- (B) At L.C/48/C/E in DNR station, private no. sheet was used without obtaining proper signature of issuing official. Issuing official must append their signature before issuing Pvt. No. sheet and maintain proper log book.
- (C) At AYRN station in SEE division, ESP shown Line No.01 as connected to Goods shed line but physically this is not available. Proper correction should be made if any variance is found out anywhere.
- (D) At PTRU station in DHN division, it was seen that LP/ALP & Train Manager do not sign on Load Stabling register. SMs must be alert and ensure that load stabling register is properly signed & all relevant columns filled when ever a load is stabled.
- (E) Form N0. T/609 and Arm Band were not available with Train Manager of Train No. 12301. He was also not aware about the 'Chalak Dal App' and 'ECR Pasand App'.

### **3. Items requiring special attention in DECEMBER , 2023**

#### **General**

- (i) Special emphasis on Securing of Vehicles as per rule.

#### **Operating**

- (i) Proper maintenance of register of winter patrolling and action if Patrolman turn-up late or report at the station late.
- (ii) Ambush checking at level crossing gates.

**Personnel**

- (i) Updating of service records of safety category staff.

**Mechanical**

- (i) Training of Maintenance staff for BMBS including APM attention and checking during ROH attention.
- (ii) Checking of dirt collector during ROH.

**Electrical**

- (i) Checking of safety equipment in Power car of Rajdhani/Garib rath and other trains.
- (ii) Strictly follow up rules of 9 hrs. duty of running staff.

**Engineering**

- (i) Work site inspections and protection as per PCE Circular No.16/2010.
- (ii) Cold weather Patrolling – Launching of intensive cold weather patrolling when temperature is less than as specified in IRPWM.

**S&T**

- (i) Ensure proper working of DATA LOGGER.
- (ii) Ensure timely overhauling of Gears.

**Security**

- (i) Intensive drive against unauthorized Level Crossing with close liaison with state government officials.

**Commercial**

- (i) Proper precaution during booking of Parcels and loading of consignment regarding explosives, inflammable items etc.
