NOTIFICATION - AFA/ADFM-70% Special drive

Sub: Selection for the post of AFAs/ADFMs(Group-'B') in Pay Band Rs. 9300-34800/-(PB-2) & Grade Pay Rs. 5400/- (L-9 in VII CPC) against 70% special drive Selection.

Ref:- Railway Board's L. No- E(GP)2022/2/4 dated 14.12.2023.

With the approval of competent authority, it has been decided to form a panel of AFAs/ADFMs (Group-'B') in pre revised Pay Scale of Rs. 9300-34800/-(PB-2) and Grade Pay Rs. 5400/- in PB-2(Level-9 in VII CPC) from amongst the eligible Group-'C' staff of Accounts Department through Selection against 70% Selection exam as a special drive through centralized CBT by NAIR in terms of Railway Board letter No. E(GP)2022/2/4 dated 14.12.2023, as per details given below:-

1. The vacancy position of Selection (70% Special drive) is as under:-

^{*01} post has been earmarked for PwBD(LD) candidates with Locomotor Disability (LD)-OA/OL/OAL/BL Leprosy Cured, Acid Attack victims in terms of Railway Board letter no- E(GP) 2022/2/20 dated 14.11.2022(PS No.3/2022) and has been included in the total vacancy.

Reservation in promotion to the Persons with Benchmark Disabilities (PwBDs) from Group-'C' to Group-'B' post will be applicable as per Railway Board letter No. E(GP)2022/2/20 dtd. 18.08.2022 & 14.11.2022 and DOP&Ts O.M.No. 36012/1/2020-Estt.(Res.II) dtd. 17.05.2022 and DOP&Ts subsequent OM No. 36035/02/2017-Estt(Res) dated 27.09.2022 will be applicable.

2. The cut-off date for assessment of eligibility of candidates for this extra round of examination is retained as <u>01.01.2023</u>. (Authority:- Rly Bd's letter no- E(GP)2022/2/4 dated 14.12 2023)

3. Notification for 30% LDCE Quota will be issued separately, when any instructions/ guidelines is received from the Railway Board.

4. Eligibility Criteria:

- 4.1 Group 'C' employees of Accounts Department working in pay band PB-2 (Rs 9300-34800) with Grade Pay of Rs 4200/- and above with three years of nonfortuitous service in the grade (including non-fortuitous service rendered in corresponding pre-revised grade) as per VI CPC or Group 'C' employees working in Level 6 and above in Pay Matrix with 3 years of non-fortuitous service in Level 6 and above in Pay Matrix (including non-fortuitous service rendered in the corresponding pre-revised grade pay) as per VII CPC Accounts Department and who have qualified the Appendix 3 (IREM) Examination who are eligible to be called for the aforesaid selection, are mentioned in Annexure-'A' & 'B'. The number of eligible Group-'C' employees in Annexure-'A' consists of 47 names (i.e 30+17) {including 17 candidates called against twice failed (inclusive of 01 SC candidate and 02 ST candidates from the extended zone). The Annexure-'B' containing equal no. of 47 employees as Stand By/Reserved list in order of seniority, as per precedence followed over this railway wherein for the selections conducted by Personnel Branch the no. of candidates in Standby/Reserve list is equal to nos. of total candidates in main list.
- 4.2 Those mentioned in Annexure-'B' will be called for CBT written test to the extent of numbers of candidates listed in Annexure-'A' express unwillingness to appear for the aforesaid selection. As such they may also be asked to be in readiness to appear for the written test.
- 4.3 In terms of DopT's OM No. 36012/1/2020-Estt. (Res.) dated 17.05.2022 circulated vide Rly Bd's letter No. E(GP) 2022/2/20 dated 18.08.2022 (RBE No-97/2022) & 14.11.2022, the PwBD candidates who are within the normal zone of consideration, shall be considered for promotion. However, if adequate number of PwBD candidates of the respective category is not available within the normal zone, the zone of consideration will be extended to five times the number of total vacancies and PwBD candidates falling within the extended zone will be considered for promotion as per list of eligible employees as per integrated seniority list. The candidates with respective category of benchmark disability for selection to Gr.B post of AFA as mentioned in under Note below Table on page 1 above are required to submit necessary PwBD certificate from authorized Medical Authority along with their consent form.

- There will be only one written examination. Any change in pattern of examination will be communicated accordingly.
- 7. As per the letter of Rly Bd under reference the seniority of empanelled Gr. 'B' officers may be fixed as:
 - a) Those already empanelled through 70% Selection & by 30% LDCE of vacancy cycle 2023-24(including extended panels (EP),
 - b) followed by those empanelled through this extra round of 70% Selection and thereafter 30% LDCE.

8. SCHEME OF EXAMINATION:

- 8.1 The Centralized CBT for 70% Selection will be held in terms of instructions contained in Board's letter No. E(GP)2022/2/4 dated 07.12.2022. The examination will consist of:
 - a) Written Examination in CBT mode &
 - b) Medical Fitness for Gr-'B' posts
 - c) Record of service & viva-voce

The marks allotted for written examination and viva-voce and qualifying marks are as under:-

(Out of 100 marks, the <u>OPTIONAL</u> question on Official Language Policy and Official Language Rules are for 10 marks each in both 70% Selection and 30% LDCE in terms of Rly Bd letter no E(GP)2022/2/4 dated 07.12.2022).

NOTE:-

- a) There shall be negative marking for incorrect answers. One-third of the marks allotted for each question will be deducted for every wrong answer.
- b) The duration of the written test will be two hours.
- c) The CBT shall be conducted by DG/NAIR, Vadodara.

- 9. The syllabus for the written exam is as prescribed by Railway Board vide letter No. E(GP)/2022/2/4 New Delhi dt. 07.12.2022 is enclosed as Annexure 'D' to this notification.
 - 9.1 Candidates have the option to give answers in Hindi or English in the written test (CBT) as well as in viva-voce.
 - 9.2 The marks prescribed for qualifying in the written examination is 60%. Such passed candidates will be directed for medical examination for Gr-'B' category as per IRMM para 530(b). On passing in the prescribed medical examination, such candidates will be called for viva-voce test. The marks of Record of Service would be given on the basis of Board's instructions contained in their letter No E(GP)2000/2/95 dtd 16.01.2001 and Para 10.4 of the Updated Master Circular No-68.
- 10. As per Railway Board letter no. E(GP)2022/2/4 dated 14.12.2023 there shall be no Supplementary examination for this special drive 70% Selection.
- 11. The above selection will be based on performance of the candidates in written examination (CBT), viva-voce and Record of Service. Only those candidates, who qualify in the written examination and found medically fit in the prescribed Medical category will be called for viva-voce test. The placement of the candidates in the panel will be based on their performance in the written examination/viva-voce & Record of Service as per extant procedure contained in Railway Board's instructions.
- 12. The list of integrated seniority of eligible candidates is enclosed at Annexure-'A' (Main List). A Standby/Reserve list, again in terms of integrated seniority is enclosed at Annexure-'B'. The Standby/Reserve candidates in Annexure-'B' are also alerted to be in readiness for appearing in the written exam at short notice in case any of staff listed at Annexure -'A' express his unwillingness to appear in the written exam.
- 13. Annexure -'A' (Main list) includes 47 names (30 candidates as per seniority list of normal zone of consideration +17 twice failed candidates (inclusive of 01 SC candidate



from the extended zone of consideration & 02 ST candidates from the extended zone of consideration) and Annexure-'B' also includes 47 names of Stand by/ Reserve list.

- 14. Tentative calendar of events is at Annexure-'F'. The target dates given in the schedule should be observed scrupulously by the controlling officers.
- 15. Representations, if any, against the seniority position, omission/commission of any name, may be submitted along-with supporting documents to controlling officer by 19.01.2024 and the same shall reach the office of Dy.FA&CAO/G by 20.01.2024. No representation will be entertained after the stipulated time period in any circumstances.
- 16. The Application Form of the candidates in Annexure- 'C' duly filled up and with specific mention of willingness/unwillingness of all the eligible candidates enlisted in Annexure- 'A' and Annexure- 'B' should be submitted to controlling officers by 21.01.2024 who shall then send it to the office of Dy.FA&CAO/G through special messenger by 22.01.2024 positively, so that final list of eligible willing candidates may be published within time frame. Controlling officers are also requested to send the all willing candidates data (in Annexure-'C') in excel-sheet to AFA/Admn's mail idafaadmnecr@gmail.com. The candidates with respective category of benchmark disability for selection to Gr-'B' post of AFA/ADFMs as mentioned in Para 1 of under Note below Table on Page 1 above are required to submit necessary PwBD certificate from authorized Medical Authority along with their consent form.
- 17. If any employee in the lists at Annexure-'A'&'B' are on leave/training/deputation/sick etc. intimation regarding this notification should be sent to their personal address and their acknowledgement should be obtained and forwarded to this office. The responsibility of sending intimation to their personal address rests with the controlling officers.
- 18. Branch Officers/Controlling Officers of the concerned Divisions/Units are requested to ensure that the Candidates named under Annexure- 'A' and Annexure- 'B' have filled the application in Annexure- 'C' and have clearly mentioned his/her willingness/unwillingness. If any candidate refuses to provide willingness/unwillingness within the stipulated time, a written report regarding non-submission of willingness by the candidate should be submitted to the office. Such candidates will be treated as unwilling for the above selection.
- 19. The Selection procedure has been prescribed under para-10 of the Updated Master Circular 68. The written examination for selection against 70% quota will consist of only one paper with maximum marks of 100 and Qualifying marks will be 60. The written examination will consist of one paper on professional subject including optional





- questions of 10 marks on official language policy and Rules. The questions on official language policy and Rules will not be compulsory to answer. Relaxation in passing marks to SC/ST and PwBD candidates shall be governed by extant rules.
- 20. The syllabus for the written exam is as prescribed by Railway Board vide letter No. E(GP)/2022/2/4 New Delhi dtd 07.12.2022 is enclosed as Annexure-'D' to this notification. The question paper for the written test will be practical bias i.e. shall be designed to test the ability of the candidates to tackle the practical problem they are likely to face rather than their theoretical knowledge. The question paper will be bilingual i.e. Hindi and English as per extant instructions. However, it will be candidate's choice to write the answer either in English or in Hindi. The written Examination will be "without Books." Any change in syllabus of the examination as advised by Rly Bd./NAIR will be communicated accordingly.
- 21. The Viva-Voce will be for 50 marks (25 marks for Record of Service & 25 marks for Viva-Voce) and the qualifying marks for Viva-Voce will be 30 including at least 15 marks in record of service. Relaxation in passing marks to SC/ST and PwBD candidates shall be governed by extant rules.
- 22. The candidates are required to secure the above qualifying marks in written examination to become eligible to be sent for medical examination and those who are certified fit for the prescribed medical examination only will be allowed to appear for viva-voce as per extant rules.
- 23. It may be noted that before conducting written examination, mandatory pre-selection coaching classes for eligible SC/ST candidates will be arranged at ECR/Hajipur. As per Rly Bd's letter no- E(GP)2022/2/4 New Delhi dated 18.10.2022, the pre-selection training for SC/ST candidates is to be conducted for 60 Hrs./15 working days/online/offline. The tentative schedule of Online training programme is enclosed in Annexure- 'E'. If any SC/ST candidate refuses to undergo pre-selection coaching, a written undertaking should be obtained from him and communicated to Dy. FA&CAO/G well before the date of commencement of the training. The Controlling Officers should ensure that the SC/ST candidates under their control are spared without fail on time to participate in the training. The SC/ST candidates are also advised to insist their Controlling Officers, in their own interest, to spare them for the said training.
- 24. The Controlling/Authorized Officer should ensure issuing of individual sparing letters having duly attested specimen signature & photograph of the candidate for the written exam. The candidates without proper sparing letter will not be allowed to appear in the examination.

The above selection will be held as per procedure laid down in Updated Master Circular 68 communicated vide Railway Board's letter No. E(GP)2019/2/2/5 dated 08.07.2019 governing promotion from Gr. 'C' to Gr. 'B' and the instructions issued time to time by Railway Board and NAIR, Vadodara regarding conduct of CBT examination. The said Updated Master Circular is available on website www.indian.railways.gov.in
