#### 3. CBT (Computer Based Test)

3.1 As per Rly Bd's letter no- E(GP)2022/2/4 New Delhi dt. 10.11.2022, the Centralized Computer Based Objective Type examination (CBT) for LDCE 30% will be one stage only and will comprise of single paper of 150 marks comprising 100% objective type Multiple Choice Questions with following distribution of marks followed by Viva-voce test:

#### 5. Eligibility Conditions:

As per extant rules, Gr.- 'C' employee of Accounts Department who fulfills the following eligibility conditions as on 01.01.2023 will be eligible for LDCE 30% Special drive:-

He/She should be working in pre-revised Pay Band- 2 (9300-34800) with (i) Grade Pay of Rs. 4200 and above with a minimum of 5 years of nonfortuitous service in the grade (including non-fortuitous service rendered in corresponding pre-revised grades) in Accounts Department & as per VII CPC Group-'C' employees working in Level-6 and above in pay matrix with five years of non-fortuitous service in Level-6 and above in pay matrix with five years of non-fortuitous service in Level-6 and above (including non-fortuitous service rendered in the corresponding pre-revised grades) will be eligible. Further, as per the instructions issued vide RBE No-40/2008, employees transferred on request basis to this railway in same category of posts, and assigned bottom seniority therein, the service rendered by them in the previous unit shall be reckoned for determining the eligibility, subject to the condition that the length of service which is so allowed does not exceed the length of the service of their immediate senior in this Railway.

- (ii) He /She should have passed the Appendix-3 (IREM) Examination as on the cut-off date.
- Note:- (A) The stenographers who are working in Accounts Department are eligible provided they fulfill criteria of minimum of five years of non-fortuitous service in the grade Rs 4200/- Level-6 and above in VII CPC and should have passed the Appendix-3 (IREM) Examination as stated under Para 4 (i) & (ii).
- (B) As per Railway Board letter no- E (GP)2005/2/74 dated 13.03.2008 and E(GP)99/2/22 dated 24.07.2019 in case of employees transferred at own request to East Central Railway as a Junior Accounts Assistant (GP 2800) and assigned bottom seniority therein, the service rendered by them in the previous unit (in GP Rs 4200) may be reckoned for determining their eligibility as the minimum length of service in prescribed as a condition, for promotion in this Railway, subject to the condition that the length of service which is so allowed to be counted does not exceed the length of service of their immediate senior in this unit and the candidate must be promoted before cut-off date in GP Rs 4200/- Level-6 in this Railway.

- 6. Syllabus for the CBT Examination: The syllabus for this 30% LDCE in respect of Group-'B' post of AFA in Accounts Department would be as modified vide Rly. Bd's letter No. E(GP)2022/2/4 dated 07.12.2022 and has been detailed as Annexure-'A'. Any change in syllabus for LDCE 30% examination as adivsed by Rly Bd or DG/NAIR in future will be communicated accordingly. Candidates are advised to visit Railway Board website or NAIR website for further information.
  - Note: 1. Optional Questions on Official Language policy and Official Language Rules in the LDCEs shall be included in terms of provision contained in Para 204.3 of IREM Vol-1.
    - 2. The relaxation for CBT examination as admissible for SC/ST candidates will be provided as per extant rules.
    - 3. CBT for 30% LDCEs for a particular department for Zones/Pus will be held on the same day across Indian Railways. Thereafter no request for a supplementary exam shall be entertained in any condition.
    - 4. Any change in Syllabus of LDCEs or in the pattern of examination as advised by Rly. Bd or DG/NAIR in due course will be communicated accordingly.

Note: Out of total 50 marks as under 6 (a) and 6 (b) above, the candidate under UR will require 30 marks including at least 15 marks in the Record of service to qualify and SC/ST candidates will require 18 marks including at least 15 marks in the Record of Service to qualify.

#### 7. Pre-Selection Coaching:

- 7.1 It may be noted that before conducting CBT examination, mandatory pre-selection coaching for SC/ST eligible candidates will be arranged online at E.C.Rly, Hajipur. As per Rly Bd's letter no- E(GP)2022/2/4 New Delhi dated 18.10.2022, the pre-selection training for SC/ST candidates is to be conducted for 60 Hrs/15 working days in online or offline mode. The tentative schedule of training programme is enclosed as Annexure-'C'.
- 7.2 If any SC/ST candidates refuse to undergo pre-selection coaching, a written undertaking should be obtained from him and communicated to the office of Dy.FA&CAO/G well before the date of commencement of the coaching. The Controlling Officers should ensure that the SC/ST candidates under their control are spared without fail on time to participate in the coaching. The SC/ST candidates are also advised to insist their Controlling Officers, in their own interest, to spare for the said coaching. The date and timing of pre-selection coaching may undergo change due to unavoidable circumstances.

- 8. Candidates who qualify CBT examination will be subject to medical examination of prescribed standards before the Viva-Voce and only those who qualify in the medical examination shall be called for the Viva-Voce.
- 9. Controlling Officers should ensure adequate publicity amongst all eligible staff working under their control. All staff of Accounts Department who fulfills the conditions of eligibility as on the respective cut-off dates may submit their application in the prescribed proforma as at Annexure- 'B' to their controlling officer latest by 12.04.2024. Application of the candidates should be forwarded by Controlling Officer with signature and date and sent through special messenger to the office of Dy.FA&CAO/G by 15.04.2024 positively. Applications received after due date will not be considered.
- 10. The Controlling Officer will check the correctness of all the particulars of applications with the service records and other relevant records and a certificate may be given by the controlling officer in this regard that all the data furnished by the candidate has been checked and verified. The applications received without such certifications will summarily be rejected.
- 11. The controlling/Authorized Officer should ensure issuance of individual sparing letters duly attesting specimen signature and photographs of the candidate on the sparing letter. The candidates without sparing letter will not be allowed to appear in the Centralized Computer Based Objective Type examination (CBT).
- 12. This LDCE-30% will be held as per procedure laid down in Updated Master Circular 68 communicated vide Railway Board's letter No. E(GP)2019/2/5 dated 08.07.2019 governing promotion from Gr. 'C' to Gr. 'B' and the instructions issued by Rly Bd vide letter no- E (GP)2022/2/4 New Delhi dated 28.06.2022, dated 22.07.2022, dated 22.09.2022 & dated 10.11.2022 and other instructions issued from time to time by Railway Board. The said Updated Master Circular is available on website www.indianrailways.gov.in.
- 13. As advised in terms of Board's letter no. E(GP)2022/2/4 dated 28.06.2022 and 28.10.2022, the Question paper will be of 150 marks. Qualifying marks will be 60% and above with relaxation as per extant instructions for reserved category candidates for reserved posts.
- 14. There is no change in the existing procedure for Medical Examination and Viva voce and assessment of APARs including the marks prescribed for them.
- 15. The tentative schedule of events of Special drive 30% LDCE (CBT) is attached as Annexure-'D'. The list of controlling officers is provided at Annexure-'E'.
