

2. Eligibility:

- (i) Staff of the Personnel department working in Level-7 (equivalent to scale Rs. 9300-34800/- with G.F. Rs. 4600/- of 6th CPC) or one Level below (i.e. in scale Rs. 9300-34800/- with G.P. Rs. 4200/-) on regular basis.
- (ii) The staff should have completed at least five years service in Railways as on date of notification.
- (iii) Staff who have aiready completed their tenure in the vigilance organization of zonal railways/units/Railway Board earlier as Vigilance Inspector/Investigating Inspector (Vig.) are not eligible.
- (iv) The integrity of staff should be beyond doubt. Staff should have clear Vigilance history and should not have undergone any penalty in Vigilance/SPE cases.
- (v) Working knowledge of computer is essential.
- 3. The selection will comprise of a written test followed by a Vigilance Aptitude & Computer Knowledge Test. Questions in written test may be asked from R.S. (D&A) Rules, 1968; R.S. (Conduct) Rules, 1966; Establishment matters, General awareness and matters pertaining to the Personnel Department etc.

4. The normal establishment rules applicable to regular selection posts ae not applicable in the selection of Vigilance Inspectors [as per para 821.5 of the Indian Railway Vigilance Manual].
