Sub: Joint inspection of Station yard by SSE/PWay, SSE/Sig & TI.

It has been observed that measurements of station yards are not matching with the approved ESP at many places as a result there is difficulty in preparation of SIP for Kavach. This situation has arisen due to non/late preparation of Completion ESP/SIP. Even it has been noticed that the completion ESP is being prepared by just copying the approved ESP without site verification after completion of works by the executing agency.

It has been decided to launch a drive to take measurements of the station yards jointly by SSE/PWay, SSE/Sig & TI and compare with the completion/approved ESP. If there is discrepancy with the approved ESP then completion ESP should be prepared with required correction, if completion ESP has not yet been prepared by the executing agency. If completion ESP is already prepared and there is mismatch with the field data then the revised completion ESP should be prepared and approved. The completion ESP or Revised completion ESP where needed to be prepared by the executing agency/division.

If there is necessity of correction/updation of ESP/SIP based on Joint measurement then that should be recorded and joinly signed by SSE/PWay, SSE/Sig & TI .The report of the same to be sent to Dy CSTE/D&D/HJP through Sr DSTE for early finalization of Completion SIP. Completion ESP should be sent subsequently by concerned Sr DEN to Dy CSTE/D&D/HJP.

Divisions to give priority for joint inspection to yards as per targeted Kavach/ABS works, recently commissioned works and other works.
