	Inspection of TRS/GMO SHED :	
1	A new Stores Depot building (about 800 Sqm) is at the final stage of construction likely to be completed in next 3 months. But this is very low height Building of not a Good design. There is 01 existing ward of about 600 SqM (18Mx32M) of Sufficient height, where presently, the receipt and storage of materials is done.	Sr. DMM/DHN AMM/GMO
2	However both the building are not fit for mechanized material handling/ storage at present. To ensure the same	Sr. DMM/DHN AMM/GMO
(a)	Following minor Modification /Variation of ongoing work be done:- i) A dock leveler (JOST/Neelkamal) with ramp with 10% gradability for mechanized unloading/Loading of material may be provided by adding new item in the ongoing work. ii) There are several partitions (non load bearing) in the existing old godown. The same may be dismantled (so that new racking system can be installed and MH be mechanized). A gate (preferably motorized) of about 4Mx4M, should be provided for entry of material from the newly constructed godown side. iii) Iron Grills are to be provided at suitable locations of the Varandah of newly constructed godown to secure it. Ramp is also needed with 10% gradability for FLT to climb to the godowns. iv) The Open space in front of newly constructed godown is quite insufficient/ narrow. To ensure free movement/stabling of Trucks, the boundary wall on the south west side be sifted outwards to create more space. v) Apart from Main Gate, one more Gate be provided on the road going towards wheel shop, so that the Depot Area is completely secured. Suitable layout may be made by AMM/GMO in consultation with AEN/GMO and get it approved.	Sr. DMM/DHN AMM/GMO AEN-I/ GMO
