Sub:-Re-engagement of retired Para-medical staff (Nursing Superintendent level-07) in Danapur division on contract basis.

Applications are invited for re-engagement of 04 paramedical staff on contract basis from retired employees who are willing to work as Nursing Superintendent (Level-07) in Danapur Division. Nursing Superintendent who are retired from Railway may submit their applications for consideration of the re-engagement.

The re-engagement shall be upto 30.06.2025 or availability of RRB empanelled candidate, whichever is earlier.

The applications (in prescribed format) must reach by hand or by post in the office of the undersigned upto 18.00 hours on 23.10.2024.

TERMS AND CONDITIONS FOR RE-ENGAGEMENT OF RETIRED PARA-MEDICAL STAFF (NURSING SUPERINTENDENT LEVEL-07) IN DANAPUR DIVISIONAL RAILWAY HOSPITAL ON CONTRACT BASIS.

1. Dismissed/Removed/Compulsory Retired Employees and also who have been punished under Discipline & Appeal Rules, during last 05 years are not eligible.
2. The Candidates will have to make their own arrangements for their stay in Danapur at the time of interview.
3. Duty hours for the re-engaged candidates shall be the same as for the incumbent of the concerned post. The posting of the staff shall be as per the requirement of the Medical Department in Danapur division.
4. The re-engagement shall be upto 30.06.2025 or availability of Direct recruitment candidate from RRB, whichever is earlier.
5. The validity of contract of re-engagement shall be upto 30.06.2025 or the date of attaining the upper age limit of 65 years.
6. A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. This amount of remuneration shall remain unchanged for the term of contract.

7. No increment, Dearness Allowance and HRA shall be allowed during the term of the contract.
8. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between residence and place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
9. Paid Leave of absence may be allowed at the rate of 1.5 days for each completed month of service.
10. Medical fitness is stipulated medical classification shall have to be obtained from Railway Hospital/Danapur before joining but after selection.
11. At the time of entering into the contract, candidates shall be produce original PPO.
12. The administration is at liberty to terminate the services of the re-engaged employees even before 30.06.2025 in case their work/conduct is found unsatisfactory or due to any other reasons
13. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
14. Posting of selected candidates within Department of Division of East Central Railway, Danapur would be decided by the competent authority. Selected candidates would be required to join within 10 days of their selection result being published, failing which their selection is liable to be treated as cancelled.
