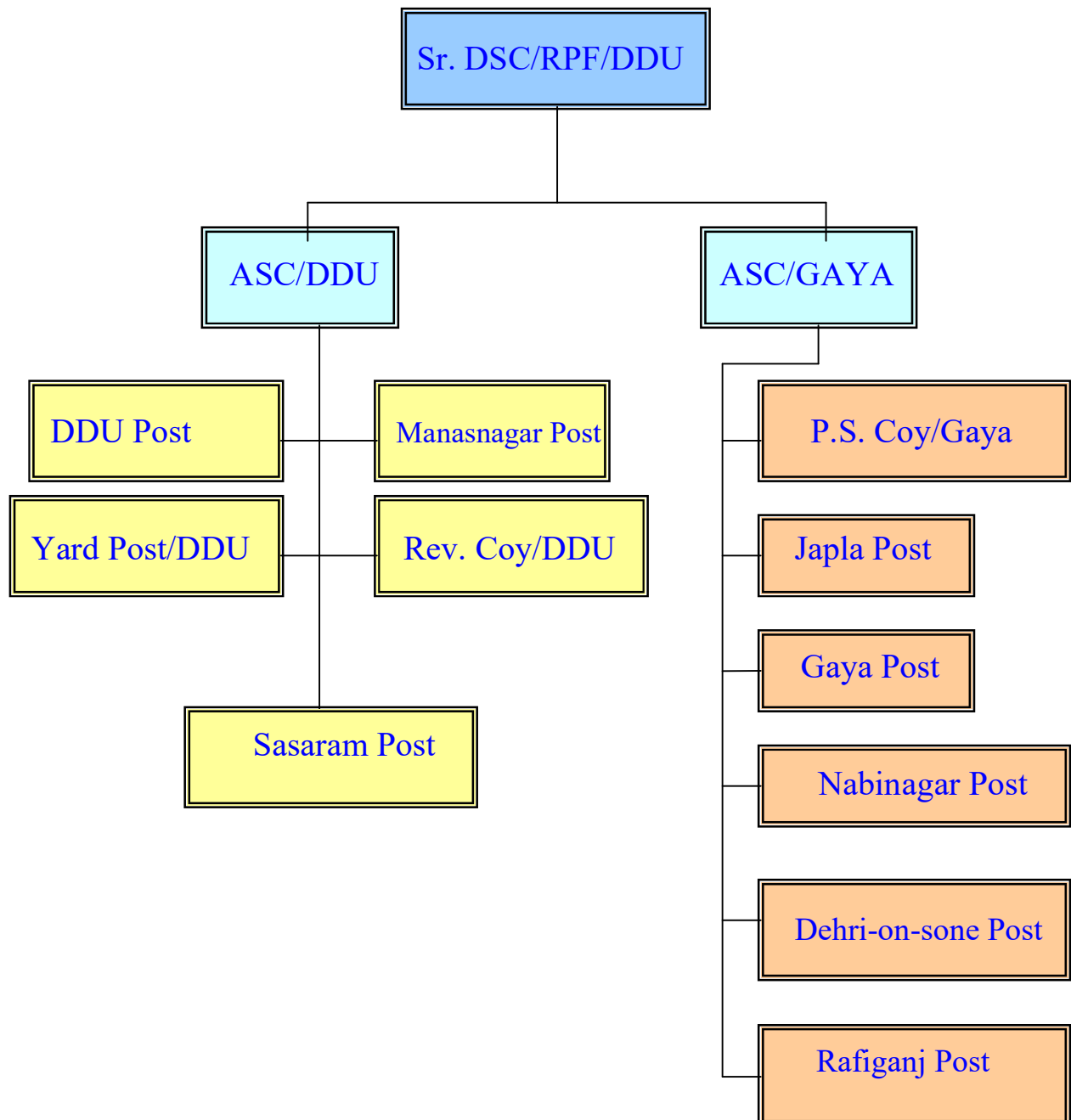

RPF- ORGANIZATION SETUP

- I. Security Branch of Pt. Deen Dayal Upadhyay Division is headed by Sri Jethin B. Raj, Sr. Divisional Security Commissioner, who is assisted by two Assistant Security Commissioner one at DDU and another one at Gaya.**
