2. Eligibility condition:

a) All serving employee having qualification of ITI/Act Apprenticeship pass in the relevant trade or 10 + 2 in Science Stream with minimum three years of service in skilled grades i.e. Technician Gr.III of Elect./TRD Department of Dhanbad Division.

b) ITI/Act Apprenticeship should in trades relevant for eventual absorption in the category in

which the selection is conducted i.e. trades relevant to the post of JE/TRD.

c) If the employee is having qualification of Degree or Diploma in the relevant branch of Engineering, are also be eligible to volunteer to appear in the selection for induction as Intermediate Apprentices alongwith those with the qualification of ITI/Apprenticeship or 10+2 (Science Stream).

d) Volunteering staffs should be below the age of 47 years in case of UR candidates and upper

age limit of SC-ST employees would be 52 years.

e) Cut of date for determining the eligibility of the staffs should be the date of issue of notification. As such volunteering employees should stand fulfill the service conditions of age and educational qualification and other conditions on the date of issue of notification.

### Mode of selection :

a) Selection will be of professional ability shall consist of written test only.

- b) The candidate has to obtain a minimum of 60% marks in professional ability i.e. written examination, for being considered for further selection process of perusal of service record and APARs. The post of Junior Engineer being classified as "Safety Category post", there is no relaxation in qualifying marks to employees belonging to the category of SC/ST and hence they are also required to secure 60% marks in the written examination at par with unreserved employee.
- c) The names of selected candidates will be arranged in the order of merit as per extant rules.
- d) Final panel will be subject to found fit in medical classification of B-1 (BEE ONE).

# 4. Procedure of written examination:

Question paper will be 100% objective type.

ii) The entire question will be of multiple choices only.

- Written examination will be in the mode of pen and paper and will be conducted OMR sheets.
- No corrections (Cutting/overwriting/erasing/multiple option) of any type to objective type answers will be permitted
