On being found medically fit for the post of AEE (Gr."B") against 30% quota as a special drive, the above mentioned candidates will be allowed to appear in the viva voce. Candidates should be advised to keep themselves in readiness for viva-voce. The date of viva-voce will be intimated shortly.

The candidates working in Divisions/Units will be medically examined in "SAFETY CATEGORY" for the post of AEE (Gr."B") by concerned CMS/MS of the Divisions/Units. Candidates working in HQ/HJP will be medically examined by CMS/SEE. APO (Rectt.)/HJP will issue Medical Memo for concerned HQ/HJP staffs. Concerned personnel Officer of the Divisions/Units will issue the Medical Memo for the candidates of Divisions/Units.

SDGM/ECR is requested to send the SPE/Vigilance clearance & PCSC is requested to send the RP(UP) cases clearance of the above employees to Dy.CPO (Gaz.)/ECR/HJP by 14.11.2024.

Controlling officers are advised to sent the DAR/SPE clearance certificates along with Medical fitness/unfitness certificate and duly completed APARs/ACRs (APARs generated by HRMS should be attested by the gazette officer) of five years (2017-18, 2018-19, 2019-20, 2020-21 & 2021-22) of the above named staff working under their control to Dy.CPO(Gaz.)/HJP by 14.11.2024 positively. Concerned personnel officers are also advised to sent the updated Service Records with TOP Sheet duly filled in prescribed format indicating undergoing punishment, if any, duly signed by the cadre officer to Dy.CPO (Gaz.)/HJP by special messenger before 14.11.2024.
