Sub. : Induction of Track Maintainer-IV & III of Civil Engineering Department of SPJ Division into Traffic (Optg.) Departments against 10% Lateral Induction quota.

In terms of Para 179 (XIV) of IREM Vol.-I, 10% of vacancies in S&T, Mechanical Engineering, Electrical Engineering & Traffic in Division have to be filled by transfer through 10% Lateral Induction quota from amongst regular Track Maintainers of Engineering Department.

Accordingly in the first phase it is proposed to fill up a total of 31 (UR-16, OBC-8, SC-5 & ST-2) vacancies in Level-1 Pay Matrix (PB-1) in Pointsmen-B Category in Traffic Departments in this division against 10% Lateral Induction quota by calling volunteers from the regular Track Maintainers-IV/III, Level-1/2 (TM-III, Level-2 also can apply, if they are willing for reversion in Level-1) of Civil Engineering Departments working on both Open Line & Construction Organization.

The Category-wise and community-wise break-up of the 31 vacancies are as under:-

Applications in the prescribed proforma enclosed as Annexure-"A" are invited from the eligible regular employees working in Track Maintainer-IV & III category in Level-1/2 Pay Matrix (PB-1) in Civil Engineering Department for transfer/induction to above mentioned category of posts in this Division, who fulfil the following eligibility criteria and terms & conditions :-

- (i) The employee should be working in Track Maintainer-IV & III in Level-1/2 Pay Matrix (PB-1) and should have the aptitude to work in the post for which he had volunteered for induction.

- (ii) The employee working as Track Maintainer-III, Level-2 possessing the required eligibility conditions, if desires to transfer to other department through lateral induction will be allowed to do so, if he accepts reversion to Level-1.
- (iii) The employee should be suitable in all respects for such transfer/induction to the post for which he has volunteered including possessing physical standard prescribed for recruitment to the said post. They should be medically found fit in the medical classification prescribed for the post.
- (iv) For transfer to other department Track Maintainers should be suitable in all respects i.e.,
 - (a) Be literate
 - (b) Possesses physical Standards prescribed for recruitment to that department.
 - (c) Have aptitude for work to which they are to be transferred.
 - (d) Must have put in at least 08 years regular service as Track Maintainer Category.
- (v) The employee should be free from DAR/SPE/Vig. cases.
- (vi) The employees who are transferred to other departments against 10% quota will count half the length of continuous service for seniority in the new cadre in which they are absorbed.
- (vii) The suitable candidate would be considered as per their Inter-se-seniority after screening of applications invited solely for the purpose of Lateral Intake.
- (viii) The employee should be willing to work at any station of this division in the event of his induction to the post for which he volunteered.
- (ix) Induction of the shortlisted employees to the posts for which they have volunteered will be subject to their qualifying in the initial training course, wherever prescribed.
- (x) The employees working in Track Maintainer-IV/III, Level-1/2 category of this division should submit their applications for the posts/vacancies notified.
- (xi) Track Maintainer-IV & III in Level-1/2 Pay Matrix (PB-1) working in Construction Organization should submit their applications only if their lien is being maintained in SPJ Division.
- (xii) It may please be noted and notified to the staff that, mere submission of the application by the employee will not give him any right for transfer/induction to the post for which he volunteered against 10% Lateral Induction quota.
- (xiii) The employees will be shortlisted on the basis of seniority based on the length of service, however subject to their suitability in all respects for such lateral induction to the post for which they have volunteered including possessing physical standards prescribed for recruitment to the said post and also subject to their qualifying in the initial training course, wherever prescribed.
- (xiv) All eligible employees who submit their applications (In the prescribed proforma and complete in all respects) for the post notified above will be screened by a committee of Jr. Scale Officers (One officer from Personnel Department, one officer belonging to reserved community and one officer from Department concerned) constituted by DRM and will be shortlisted on the basis of seniority based on the length of service. Induction of the shortlisted employees to the posts for which they have volunteered will be however subject to their suitability in all respects for such transfer/induction to the post for which they have volunteered including possessing physical standards prescribed for recruitment to the said post and also subject to their qualifying in the initial training course wherever prescribed.

The eligible employees in Track Maintainer-IV & III Category in Level-1/2 Pay Matrix (PB-1) fulfilling the eligibility conditions mentioned above may submit their applications in prescribed proforma, complete in all respects, to the office of Sr. DPO/SPJ on or before 09.12.2024.

The eligible employees in Track Maintainer-IV & III Category in Level-1/2 Pay Matrix (PB-1) fulfilling the eligibility conditions mentioned above may submit their application form in prescribes proforma by e-mail to pankaj.ksuman25@gov.in or egrsspj@gmail.com on or before 09.12.2024.
