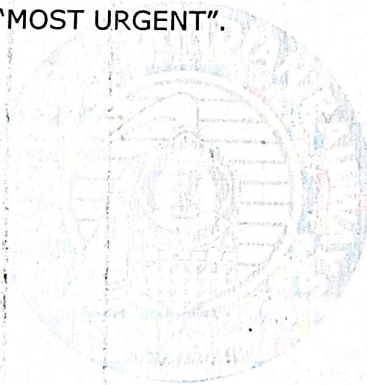

Concerned Personnel Officers of the Division/Units will issued the Medical Memo for the candidates of Division/unit.

SDGM is requested to send the SPE/vigilance clearance & PCSC is requested to send the RP(UP) cases clearance of the above employees to Dy.CPO/Gaz/ECR/HJP by **12.02.2025**.
