## **NOTIFICATION**

Sub:- Induction of Track Maintainer -IV/Engineering Department on E.C.Railway into Traffic (Operating) Department against 10% lateral Induction quota.

Ref:- (i) RBE No.41/2024, 146/2018 & 121/2013

As per instructions & with the approval of Competent Authority notification has been issued in regard to induction of Pointsman-B, Dhanbad Division, E.C.Railway against 10% lateral Induction quota amongst the total intake of Track Maintainers.

Vacancies proposed to filled up against 10% lateral Induction quota are as under:-

Applications in the prescribed proforma enclosed as Annexure-A are invited from the eligible regular employees working in Track Maintainer-IV category in Level-1 Pay Matrix in Civil Engineering department for transfer/Induction to above mentioned categories of posts in Division, who fulfill the following eligibility criteria and terms & conditions.

- (i) The employee should be working as Track Maintainer-IV in Level-1 Pay Matrix and should have the aptitude to work in the post for which he has volunteered for induction.
- (ii) The employee should be suitable in all respects for such transfer/Induction to the post for which he has volunteered including possessing physical standards prescribed for recruitment to the said post. They should be medically found fit in the medical classification prescribed for the post i.e A-2 (Aye-2).
- (iii) The employee should not be below the age of 38 years as on date of notification.
- (iv) The employee must have a minimum educational qualification of Matriculation/ITI or its equivalent.
- (v) The employee should be free from DAR/SPE/Vig. cases.
- (vi) The employee should accept that half of the length of continuous service, which qualifies for determining his seniority in Track Maintainer category will only be counted for the purpose of seniority on his transfer/Induction to the post for which he volunteered against 10% Lateral Induction quota (as per Para 179(XV) of IREM Vol.I). It is clarified that past service rendered in other unit/Railway shall not be reckoned for determining the seniority of Track maintainer under 10% lateral induction quota (Rly.Bd's letter No.E(NG)I-2020/CFP/2(e-3322378) dated 21.02.2025)
- (vii) The employee should be willing to work at any station in the division in the event of his induction to the post for which he volunteered.
- (viii) Induction of the shortlisted employees to the posts for which they have volunteered will be subject to their qualifying in the initial training course, wherever required.

- (ix) Track maintainer -IV in Level-1 Pay Matrix working in Construction Organization should submit their applications against notification if their lien is being maintained at Dhanbad Division.
- (x) Track maintainers (L-1) who have been granted MACP in G.P 1900 and above, but whose seniority is in GP 1800, may also apply for lateral induction, provided they fulfil the other prescribed eligibility criteria.
- \* It may please be noted and notified to the staff that, mere submission of the application by the employees will not give him any right for transfer/Induction to the posts for which he volunteered against 10% Lateral Induction quota.
- \* All the eligible employees who submit their applications (In the prescribed proforma and complete in all respects) for the posts notified above will be screened by a Committee of Jr.Scale Officer (one officer from Personnel Deptt. one officer belonging to reserved community and one officer from Deptt.concerned) constituted by the Competent Authority and will be shortlisted on the basis of seniority, based on the length of service.
- \* The eligible employees in Track Maintainer Gr.IV category in Level-1 Pay Matrix fulfilling the eligibility conditions mentioned above may submit their applications (In which they are working/in which their lien is maintained, in case of Construction staff) in prescribed proforma, complete in all respects, to their immediate supervisor on or before 06.05.2025. The AEN concerned should forward the applications received from all the eligible employees in one bunch separately for the category of post to "Suvidha Kendra" office of Sr.DPO/E.C.Railway, Dhanbad Division on or before 06.05.2025 through ADENs concerned with DAR clearance of the employees concerned.

Applications received in Sr.DPO's office, after the due date advised above will not be entertained under any circumstances.

It is requested to give wide publicity to the notification among the staff(s) working in Track Maintainer-IV category in the Division on Open line and also in Construction organization.
