Eligibility criteria and terms & condition

- (i) Non-gazetted Railway staff retired in Pay Level-1 to Pay Level-9 may be considered for re-engagement against the vacant posts subject to stipulation that he/she may be re-engaged against the post having the same pay-level held by him/her at the time of retirement.
- (ii) Maximum age limit for which re-engagement shall continue will be 65 years.
- (iii) While re-engaging such staff, medical fitness of the appropriate category will be obtained from the designated authorities as per existing practices.
- (iv) Retired employees being re-engaged should not have been covered under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).
- (v) Suitability/competency of the staff will be adjudged by a committee at an appropriate level before such re-engagement duly taking into account safety and other operational requirement. Re-engaged employees should also be free from DAR/Vigilance cases.
- (vi) The Railway administration reserve right to reject/not entertains any application or candidature without assigning any reason. The Railway administration also reserves the right to cancel/postpone the Screening test on administrative ground.
- (vii) Re-engagement of staff will be provisional and on temporary measure and subject to his competency and satisfactory working. Re-engagement of retired staff will remain open until the vacancies are filed or until further directives are issued by the Railway Board, whichever occurs earlier.
- (viii) Attested copies of following documents should be attached with the application: (a) Service Certificate (b) Educational Certificate (c) Pensioner Identity Card (d) Pensioner Payment Order (PPO) (e) Last Pay Slip(f) First page of Saving Bank Account Pass Book with IFSC & Account No.(g) Aadhar Card (h)Ten copies of recent passport size colour photograph.
