Sub:- Selection of **Chief Vigilance Inspector/Security** in Pay Matrix Level-7 (scale of Rs. 9300-34800 in Grade Pay Rs. 4600/- 6th PC) in Vigilance Organisation of E.C. Railway/Hajipur.

In order to fill up ex-cadre post of **Chief Vigilance Inspector/ Security** in Pay Matrix Level-7 (scale of Rs. 9300-34800/- in Grade Pay Rs. 4600/- 6th CPC) in vigilance organization E.C. Railway/Hajipur, it has been decided to hold a selection for forming a panel of **01 (ONE)** candidate from the Security Department.. The tenure of the post will normally be for three (03) years, which may be curtailed/extended as per extant rules.

Eligibility:

- (i) Staff of the Security departments of this Railways working in Pay Matrix Level-7 (scale of Rs. 9300-34800 in Grade Pay Rs. 4600/- 6th PC) or one level below in level-6 (i.e. in scale of Rs. 9300-34800/- with G.P Rs 4200/- in 6th CPC) on regular basis on the date of notification.
- (ii) The staff should have completed at least five (05) years service in Railways as on date of notification.
- (iii) Staff who have already completed their tenure in the vigilance organization of Zonal Railways/Production Units/Railway Board earlier as Vigilance Inspector/Investigating Inspector (Vigilance) are not eligible to apply. However, if they have completed sufficient cooling off period (minimum 02 years) as on date of notification, thereafter they are also eligible to apply.
- (iii) The integrity of staff should be beyond doubt. Staff should have clear Vigilance history and **should not have undergone any penalty in Vigilance/SPE case. Also the staff should not have undergone/undergoing any penalty under DAR in the last 3 years.**
- (v) Working knowledge of computer is essential.

The selection will be done by a written test followed by a viva-voce. Questions in written test may be asked from R.S.(D&A) Rules, 1968, R.S.(Conduct) Rules, 1966, RPF Rules, Establishment matters, General awareness and Matters pertaining to the Security department, etc.

Wide publicity of the above vacancy notice may kindly be given and this should also be displayed prominently on notice boards for information of the staff.

The application of the eligible volunteers duly filled up in the enclosed proforma and completed in all respect must to forwarded through proper channel, so as to reach the same to "General Manager (Vigilance), East Central Railway, Vigilance Department, Hajipur, Dist.-Vaishali, PIN-844101".

The last date of receipt of application in this office is 30.06.2025.

The selected Vigilance Inspector (s) shall have to give undertaking not to accept role of defence assistant within four (04) years of leaving the Vigilance office.

The normal establishment rules applicable to regular selection posts are not applicable in the selection of Vigilance Inspectors (as per Para No.821.5 of the Indian Railway Vigilance Manual).

Applicants, once selected will not be allowed to withdraw their names.

The posting in the Vigilance organization is on a purely temporary basis and that the Railway Administration has full right to repatriate the person at any time without assigning any reason, even if, he has not completed initial period of tenure or extension, if any granted thereto.

Vigilance is an ex-cadre organization. Therefore, staff selected for posting in the Vigilance department will continue to maintain their lien and seniority in their parent cadre.
