Railway Board, vide circulars mentioned above, has issued policy regarding participation of Indian Railways personnel in Meditation/Yoga/Spiritual and other related programmes. It has now been decided to bring out a comprehensive policy circular regarding the above.

- Following instructions may be followed: 2.
  - Special Casual Leave (SCL) upto a maximum of nine (09) days inclusive of four (04) i) days journey time would be allowed once in a year for one such programme, which would be granted by the respective Controlling officers to willing employees;
  - Special pass (as per entitlement) would be given once in a year to such Railway ii) employee who has been granted SCL by the Controlling officer;
  - No TA/DA would be payable; Tiii
  - No programme fee would be payable by Railways; and iv)
  - The official willing to participate in such programmes would be spared subject to v) the convenience of the Administration.
- Strict compliance to the above directives may be ensured by all concerned. 3.
- This supersedes all previous instructions/circulars on the subject. 4.
- This issues with the concurrence of the Finance Directorate of Railway Board. 5.
