  - (b) 50% by promotion from the amongst existing Gr'D' staff in service as on 22.05.2002 not having the qualification of class X Board Examination.**

The eligible optees i.e. Kh. /Helper (Sig) & Trolley man of S&T Deptt. will be called for the trade test, according to seniority as per Inter-se-seniority, the senior-most Kh./Helper (Sig) & Trolley man (S&T Deptt.) will be called upto equal no. of available vacancy. It is also clarified that any of the candidates not filling the terms and conditions of eligible as laid down above, his candidature will be treated as cancelled/rejected even if he is found suitable after securing qualifying marks.
