Scope of Enquiry: Chief Medical Superintendent, Div. Railway Hospital /ECR/Pt.DDU for and on behalf of the president of India, invites tender on IREPS from resourceful chemist & Medical store in DDU Nagar for emanelment of VENDRORS for rate contract of each seprate groups (medicine, surgical and consumables etc.) for period of two years. Eligibility criteria and other informations are given below:

1.	Description of Work	"Vendor empanelment for rate contract to supply medicines,surgical items,laboratory reagents ,Consumables items and other medical store related items pertaining to medical store of divisional railway hospital /DDU Divison/ECR" as per daily need basis.
2.	Period of Contract	Two Years 730 days (from the date of commencement of work/MoU issue date).Period of rate contract can be extended for a period maximum up to 3 months at a time with approval of CMS/DDU with finance concurrence .Total extension shall not be more than six months.

4.	Nature of tender	Tendering shall be single stage single packet system with open tender on IREPS. Vetting is not required if tender is e-tender on IREPS and tabulation is system generated.

9.	Eligibility Criteria	(A) General Capability: (1) Vendor /chemist/medical store shops should exist (submit/provide copy of valid licence held for above premises.) (2)Chemist/Vendor must hold valid drug licence as on the date of submission of bid in specified form issued by the drug controller authority of the uttar Pradesh under the provisions of Drug and cosmetics Act,1940.The successful Bidder will further ensure that their licence remain valid till the end of the contract period. (3) Chemist/Vendor should have valid licence/legal/local formalities for establishment as well as skilled manpower. (4) Vendor /chemist/medical store shops should have proper storage requirement and cold chain systems.

10.	Supply Conditions:	<p>(1). Service should be available 24X7.</p> <p>(2). Order will be placed through email/sms/whatsapp/HMIS to the supplier.</p> <p>(3). Material will have to be supplied within 24 hrs preferably before the closure of OPD, if the indent has been placed at least 4 hrs before closure of OPD timings.</p> <p>(4) For life saving drugs the firm has to supply within short notice preferably within in one hrs of being intimated.</p> <p>(5) Branded items should be supplied with the same name and brand only, no alternate or substitute will be accepted except with special permission of CMS/ECR/DDU.</p> <p>(6). The authorized representative of the vendor making supply can see the performance register. Vendor should Supply the medicines as per storage conditions. item will be not acceptable if found without proper storage condition and it will be recorded in performance register.</p> <p>(9).
