As such, applications are invited from the eligible staff of Coal Commercial Department of Dhanbad Division fulfilling the eligibility criteria as under:-

## 1. ELIGIBILITY:

(a) Length of service - All Staff working as Weigh Bridge Porter/Courier Clerk having regular (PB Rs. 5200-20200/- + GP- 1800/-) Level-01 in 7<sup>th</sup> PC can apply for the post of Asstt. Weigh Clerk of Coal Commercial Department.

(b) The staff must have completed 02 (two) year regular service as on the date of notification. Medical category should be C- 1

(c) Educational Qualification:- The staff appointed prior to 17.12.2014 must have passed Matriculation and the staff appointed on & after 17.12.2014 must have passed 12<sup>th</sup> (+2 stage) or its equivalent examination with not less than 50% marks in aggregate. 50% marks is not to be insisted upon in case of SC/ST/Ex Servicemen

2. MODE OF SELECTION: Written examination and assessment of records of service.

3. Last date of submission of application - The application must reach to EGRS(Suvidha Kendra)/DIIN section under Sr.DPO/DIIN office on and before 24.04.17. Sr. Subordinate will forward the application in a bunch with forwarding letter and send to EGRS(Suvidha Kendra)/DIIN section under Sr.DPO/DIIN office, Dhanbad on and before 24.04.17
