NOTIFICATION

Sub :- Re-engagement of Retired Railway Employees in Dhanbad division

Ref :- Rly.Board's letter No. E(NG)-II/2007/RC-4/CORE/1, dt. 16.10.17 & 12.12.17
(R.B.E No.150/2017 & R.B.E No.193/2017)

Applications are invited from Retired Railway Employees in cadres (annexed at Annexure-A) of East Central Railway, Dhanbad division who has retired from service on or **before 28.02.2018** for re-engagement against vacancies of East Central Railway, Dhanbad division on following terms and conditions. The department/category wise vacancy position is annexed as **Annexure- "A"** to this notification.

- (1). Railway employees retired from railway service are only eligible to apply.
- (2). The re-engagement shall be strictly up to the age of 65 years or till the availability of regular candidates from RRBs or any other mode or validity of the scheme i.e. 01.12.2019 whichever is earlier as per Railway Board's letter No.E(NG)II/2007/RC-4/CORE/1, dated 16.10.2017(RBE No.150/2017 and RBE No.193/2017)
- (3). The administration will be at liberty to terminate the services of the re-engaged employee even before 01.12.2019 in case their work/conduct is found unsatisfactory or due to any other reasons.
- (4). In this scheme, Railway employees who are compulsorily retired or removed/dismissed from service or retired voluntarily under SRSS and LARSGESS are not eligible to apply.
- (5). The monthly remuneration of re-engaged employee will be determined by reducing Pension from his/her last pay drawn (Basic + DA) and no other allowance/remuneration shall be payable in terms of Rly.Board's letter No. E(NG)-II/2007/RC-4/CORE/1, dated 16.10.17(RBE No.150/2017 and RBE No.193/2017)
- (6). The retired railway employee shall execute an agreement to abide by all the terms and condition of the re-engagement.
- (7). Suitability/competency of the applicant will be adjudged by a duly constituted committee for re-engagement and issue of safety record as well as the safety and other operational requirement as needed will be adequately addressed.
- (8). Re-engagement shall also be subject to prescribed medical fitness for the cadre in which, they are to be engaged.
- (9). Posting of selected candidates within department of East Central Railway, Dhanbad would be decided by the competent authority. Selected candidates would be required to join within 10 days of their selection which will be notified, failing which their selection will liable to be treated as cancelled.
- (10). The normal duty hours of re-engaged employee would be same as applicable to other similarly placed staff.
- (11). Attested copies of following documents should be attached with the application:-
 - (i). Service certificate.
 - (ii). Pensioner Identity Card.
 - (iii). Pension Payment Order
 - (iv). Last Pay Slip
 - (v). Saving Bank Account Pass Book.
 - (vi). Two copies of recent passport size photograph
