**Sub: Requirement of staff in Human Resource Department of DFCCIL on deputation basis.**

Dedicated Freight Corridor Corporation of India (DFCCIL), a schedule 'A' Public Sector Undertaking under the administrative control of Government of India (Ministry of Railways), is a most ambitious and biggest ever project in infrastructure sector, set-up to give economy a boost and build high capacity and high speed rail freight corridor along the golden quadrilateral and its diagonals. The first phase comprises of construction of two Dedicated Freight Corridors spanning the Mumbai-Delhi (Western Dedicated Freight Corridor) and Ludhiana-Delhi-Kolkata (Eastern Dedicated Freight Corridor).

2. At present, there are 14 field units of DFCCIL being operated in EDFC and WDFC respectively. Out of which 7 are on EDFC at Ambala, Meerut, Agra, Allahabad (E), Allahabad (W), Mughalsarai & Kolkata and the remaining are on WDFC at Mumbai (North), Mumbai (South), Vadodara, Ahmedabad, Ajmer, Jaipur & Noida.

3. To expedite the project, there is a requirement of experienced manpower in Human Resource Department for the post of AM (HR) in the Corporate Office. The eligibility criteria & job description etc. are enclosed at Annexure 'A' for Construction Phase.

4. The candidates will be posted based on vacancies at considering choice of posting.

5. Deputation will be initially for three years and further extendable for five years based on requirement of DFCCIL.

6. All Zonal Railways are requested to give wide publicity for the above requirement of staff. Applications of staff willing to join DFCCIL on deputation basis may be forwarded in the enclosed proforma alongwith D&AR/Vigilance clearance & APARs ratings (copy of APARs are not required) for the last five years clearly indicating post and preferred location of posting within 30 days of circulation of this vacancy notice.
