Sub:- Selection for the post of Assistant Electrical Engineer (Group-'B') in Level – 8 of 7th PC [Pay Band Rs. 9300-34800/- (PB-2) Grade Pay- Rs. 4800 as per 6th PC] against 70% quota.

- (1) With the approval of General Manager/ECR, it has been decided to hold a selection for formation of panel against 10 vacancies of the post of Assistant Electrical Engineer (Group-'B') against 70% quota over E.C. Railway, as per details given below: -

Eligibility (As on 13.10.2016)

The list of eligible Group 'C' employees of Electrical Department who are eligible to appear in the 70% selection is enclosed herewith marked as Annexure- "A". Annexure- "B" contains the stand-by list of employees. Annexure- "A" containing 37 names [30 employees as per 3X formulae + 5 twice failed employees + 2 from extended list of reserved category] in the main list and Annexure- "B" contains 37 names in the stand-by list in order of seniority. Candidates are advised to be in readiness to appear for written examination. The date of written examination will be advised in due course. The notification may be brought to the notice of the employees concerned enlisted in Annexure 'A' and Annexure 'B'

Normally, there is no provision for holding absentee written examination. However, in exceptional circumstances, where sufficient and satisfactory reasons/proof that absence was for reasons beyond control of candidates are available, (viz either the candidate under RMC or he was not spared by his controlling officer due to administrative reasons), only such candidates may be allowed to appear in absentee written examination with approval of the competent authority. It will be responsibility of the candidate to advice reasons of absence through controlling officer to Dy.CPO(Gaz.)/E.C.Railway/Hajipur within 03 days from the date of written examination. In case of failure to comply the above instructions by the candidate, he/she will not be allowed to appear in the absentee written examination, if held.

- (3) The above selection will be based on candidate's performance both in written examination, viva-voce and Record of Service. The candidates who qualify in the written examination followed by medical test in requisite medical category will only be eligible for viva-voce test. The placement of the candidates in the panel will be based on their performance in the written examination, viva-voce & Record of Service as per extant instructions of Railway Board.
- (4) The cut-off date of eligibility for candidates both for 70% selection and corresponding 30% LDCE (to be notified later) will be 13.10.2016.

While preparing the aforesaid list of Annexure-"A" and Annexure-"B", the provisions contained in Board's letter No. E(GP)85/1/78 dated 10.09.86, E(GP)87/2/72 dated 11.01.88 and E(GP)99/2/22 dated 29.03.10 have been taken into accounts.

Representation, if any, against the seniority position may be sent to Dy.CPO(HRD)/ECR/HJP through proper channel with a copy to Dy.CPO(Gaz.)/ECR/HJP upto 06.07.2018. No representation will be entertained after stipulated time period in any circumstances.

The willingness/unwillingness of all the candidates enlisted in Annexure-"A" and Annexure-"B" should be communicated to Dy.CPO(Gaz.)/ECR/HJP through special messenger by 20.07.2018.

- (5) Sr. DPOs/Personnel Officers of the Divisions/Units are requested to ensure that the Staff Welfare Inspector/Sectional Staff Welfare Inspector are deputed to obtain willingness/unwillingness on the prescribed proforma enclosed as Annexure- "C" from the candidates (including staff on deputation /leave/sick) of Annexure- "A" & "B". If any candidate refuses to provide willingness/unwillingness, the deputed Staff Welfare Inspector should submit a written report regarding non-submission of option by the candidate. Such candidates will be treated as unwilling for the above selection.

Above exercise should be completed within the target date and all the relevant papers should reach to Dy.CPO(Gaz.)/ECR/HJP by 20.07.2018 positively, so that a final list of eligible willing candidates may be published.

The controlling officers are also requested to co-ordinate with the Personnel Officers and staff to complete the above exercise within the given time frame.

- (6) **Syllabus:** The written examination for selection to the post of AEE (Gr 'B') 70% will consist of only one paper. Maximum marks of the written exam will be 150 and Qualifying marks will be 90. Out of 150 marks, professional subject will carry 100 marks. In terms of Railway Board's letter No. Hindi-2010/OL-1/10/4 dated 14.12.2016, question(s) worth 15 marks out of total of 150 marks, will be on the subject of official language policy and rules, which will not be compulsory to attempt. Since AEE is safety post, no relaxation is admissible to SC/ST candidates as per extant rules.

As per Para-204.2 of IREM, Vol-I, no syllabus has been prescribed.

The question paper will be bilingual i.e. in Hindi & English both as per extant instructions. However, it will be candidate's choice to write in English or in Hindi.

- (7) **TRAINING OF SC/ST CANDIDATES:** It may be noted that in terms of Railway Board's letter No. E(MPP)/96/3/23 dated 21.07.2000 before conducting written examination, mandatory pre-selection coaching of 3-4 weeks (21 working days) to all SC/ST eligible candidates will be arranged by the department concerned. PCEE will nominate the In-charge(s) of pre-selection coaching. The In-charge(s) of pre-selection coaching will also intimate the date and venue of the pre-selection coaching in due course.

(7.1) **Duty of the In-charge of pre-selection Coaching (To be nominated by PCEE):**

- (i) To inform in writing through special messenger to the eligible SC/ST employee regarding date, time & venue of coaching.
- (ii) To obtain in writing the unwillingness to attend the coaching, if any, from the eligible SC/ST employees.
- (iii) To co-ordinate and arrange sparing of the eligible SC/ST candidates.
- (iv) To chalk out coaching schedule.

(7.2) **Duty of Controlling Officer:-**

To spare the candidates under their control without fail in time with the direction to participate in the pre-selection coaching as well as to appear in the written examination also.

(7.3) **Duty of concerned SC/ST applicant:-**

- (i) To arrange their sparing from duty by insisting their controlling officers in their own interest.
- (ii) If any problem occurs in sparing, the candidate should report in writing to concerned In-charge of pre-selection coaching on the same date. No representation will be entertained in case of failure to report to the concerned In-charge of pre-selection Coaching and it will be deemed to be refusal for the same.
- (iii) Failure of concerned SC/ST employees to avail pre-selection coaching on any account including leave etc. will be considered on their part and no supplementary coaching will be organised in any circumstances.
- (iv) No appeal will be entertained by GM(P)/ECR/HJP office after completion of pre-selection coaching.

- (7.4) As per PCEE/ECR's letter No. ECR/ELE/CON/AEE-Gr.'B'/70% dated: 01.06.2018, the necessary pre-promotional coaching to 30 SC/ST employees is being imparted from 04.06.2018 onwards for 21 working days.

After completion of pre-selection coaching, the In-charge of the pre-selection coaching will give a written report along with all supporting papers including attendance sheet of SC/ST participants to Dy.CPO/Gaz/HJP latest by within 03 days after completion of training.

- (8) The Controlling/Authorized officer should ensure to issue individual sparing letter/identity slip duly attesting specimen signature of the candidate on the sparing letter/identity slip with direction to attend the written examination (date will be advised in due course). The candidates without proper sparing letter/identity slip will not be allowed to appear in the examination.
- (9) The above selection will be held as per procedure laid down in Master Circular- 68, governing promotion from Gr. 'C' to Gr. 'B' issued by Railway Board and the instructions issued from time to time. The said master circular is available on website www.indianrailways.gov.in....>Ministry of Railway...>Railway Board> Directorate... >Establishment...>E(GP) Master Circular. The Department/Division/ Unit should ensure the compliance of instructions of item No.-15 of Master Circular-68.
