Esstt. Office Order No.- 613 /02/Posting/Goods Guard/2019

The following Orders are issued with the approval of the competent authority to take immediate effect.

On being empanelled by RRB/Patna for appointment in Goods Guard in scale Rs 5200-20200/-G.P. RS 2800/-in 6th CPC & Level-5 in 7th CPC and on accepting the terms and condition as mentioned in the offer of appointment letter NO-E/Rectt/Goods Guard/17 dated 29.01.18 and also on being declared medically fit in the prescribed medical category, the following candidate has successfully completed initial course training at ZRTI/Bhuli , line training (Single & double) in DHN Divn .

He was initially sent to ZRTI/Bhuli for initial training from 11.06.18 to 17.07.18 vide this office letter No. E/Rectt/Goods guard/18 dt. 08.06.2018 but declared fail vide ZRTI/Bhuli's letter No.ZRTI/08/Guard/ini/prom/18 dt. 09.06.18,

He was again sent to ZRTI/Bhuli in repeat course from 01.10.18 to 13.10.18 vide this office letter dated 28.09.2018 and declared pass vide ZRTI/Bhuli's letter No.ZRTI/08/Guard/Repeat/18dt. 24.10.18 .

At the time of drawing Stipend in IPAS, it was detected that Sri Ranjeet singh is an employee of MGS Divn. Of E.C. Rly in the capacity of Helper-II in Mech(C&W) Dept. As such he had furnished false information at the time of appointment, as such his previous training/service of Goods Guard is treated as null & void. In terms of Rly Service Conduct Rules 15(b), "No Rly. Servant shall, accept with the previous sanction of the Government negotiate for or undertake any other employment.

In terms of DRM(P)/ DRM(P)/MGS 's letter No. MERS/Gr.D/C&W/Resign./MGS/18 dt. 12.12.2018 "simple resignation has been accepted by the competent authority on & from 12.12.2018 in f/o Sri Ranjeet singh . Accordingly the competent authority passed an order to allow him to join afresh if, it is conformed that the Master Data/ Biodata is accept in IPAS and if he submit declaration in writing that he will not claim any remuneration prior to his resignation.

Considering his declaration dated 11.02.2019, he is now posted as Goods Guard in Optg Deptt on pay Rs.29200/-+ usual allowances in Level-5 in 7th CPC as per RBE No.90/2016 at the station/ Section mentioned below.
