The date of taking independent charge as Jr.Clerk at DHN under Sr DME/C&W/DHN should be intimated to this office for record.

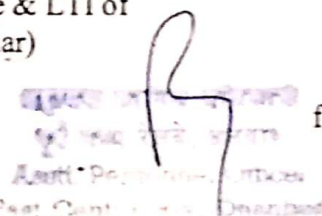
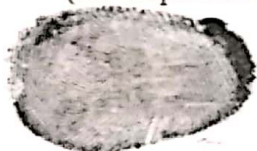
