As per RBE No.-03/2019 the staff who completed **02 (Two)** years of service in Grade as on 25.03.19 will only be eligible to apply for the above post. The service rendered from the date of attaining temporary status should only be taken into account for counting continuous service followed by absorption against vacancies in Gr.-D category as a regular measure.

**Educational Qualification:** The candidate must be passed Class-VIIIth (Attested Copy of certificate to be enclosed).

**MODE OF SELECTION:** Written examination and assessment of Service Records.

As per instructions laid down in RBE No. 196/2018, the question paper will be 100% Objective Type and will be multiple choices only. The examination will be conducted in CBT mode or pen and paper depending on their preparedness. If it is not implemented the tests may be conducted on OMR sheets. In the answers cutting, overwriting, erasing or alteration of any type will not be accepted. Zero marks will be given for Answer having correction/overwriting. There will be negative marking for incorrect Answers. One third of the marks allotted for each question will be deducted for wrong Answers.

**The date of submission of application:** The application must reach to **Ch.OS/ ET-1 section/DRM Office Dhanbad** on or before 24.04.19. Sr. Subordinates/Supervisor will forward the application individually of eligible and willing candidates in a bunch and send to **Ch.OS/ ET-1 section/DRM Office Dhanbad** on or before 24.04.19 positively.

No application will be allowed after the scheduled date.

The candidates selected finally will have to undergo promotional course training at ZRTI/Bhuli and on successful completion of training & Line training, they will be posted as AWC in Scale Rs. 5200-20200/- G.P-2000/-(Level-3)
