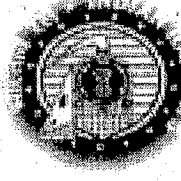





Sub: Extension of free educational facilities to the wards of Licenced Porters in the schools run by the Railways/Railwaymen Organisations/Mahila Samities.

Consequent upon the announcement made by Hon'ble Minister of Railways in the Budget Speech for the year 1995-96, it has been decided that free educational facilities should be extended to the wards of Licenced Porters in the schools run by Railways and Railwaymen's Organisations/Mahila Samities. This should be given wide publicity among the Licenced Porters so that they can avail of this facility.

2. The schools run by Mahila Samities and Railwaymen's Organisations should be suitably advised in the matter. It may happen that these schools may have to incur some expenditure in imparting free education to wards of Licenced Porters. In such cases, the schools may be suitably compensated by grants-in-aid as provided under the Rules.
