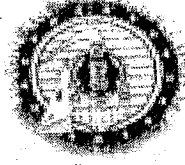

Sub: **Promotional prospects of Pointsmen category.**

Pulling

The issue regarding promotional prospects of Pointsmen category of the Traffic Department has been under consideration of the Railway Board.

The matter having been taken up by both the recognized Federations i.e. NFIR and AIRF has been examined, in consultation with the Traffic Directorate.

With a view to improve the promotional prospects of the Pointsmen category, it has been decided that Pointsmen 'A' in Pay Level-2 may also be considered for selection to the post of Jr. Trains Clerk in Pay Level-2 along with the other eligible categories in Pay Level-1. As such placement of Pointsmen 'A', if selected to Jr. Train Clerk, will however be a movement from a Level-2 post to the same level of post, it is clarified that fixation of pay with promotional increment under Rule 13(i) of RSRP rules, will not be done in such cases.
