With approval of the General Manager, it has been decided to hold a selection for formation of the panel against 08 vacancies for the post of AOM (Group 'B') against 70% quota over E.C. Railway as per details given below:-

1. TENTATIVE DATE OF WRITTEN EXAMINATION

- (a) Date of written examination: 31/7/2019
(b) Venue : Old Conference Hall, E.C. Rly/HQ office/ Hajipur.
(c) Reporting Time : 10.00 hours.
(d) Time duration : 11.00 to 14.00 hours.

2. Eligibility (As on 01.11.2018)

- 2.1 The list of Group 'C' employees of Operating Department who are eligible to appear in the in the selection to the post of AOM/Gr. B against 70% quota according to seniority is enclosed herewith as Annexure 'A'. Similarly, a standby list of employee is also enclosed as Annexure 'B'. Annexure 'A' containing 34 names (24 employee as per 3X formula i.e (8 x 3=24 + 10 twice failed) candidates) in the main list and Annexure 'B' also containing 34 names in the stand-by list in order to seniority. Candidates are advised to be in readiness to appear for written examination. The notification may be brought to the notice of the employees concerned enlisted in Annexure'A' and Annexure'B' respectively.



- 2.2 Normally, there is no provision for holding the absentee written examination. However, in exceptional circumstances, where sufficient and satisfactory reasons beyond the control of the candidates are available, (viz either the candidate is under RMC or he was not spared by his controlling officer due to administrative reasons), only such candidates may be allowed to appear in absentee written examination with the approval of the competent authority. It will be responsibility of the candidate to advise reasons of absence through his controlling officer to Dy.CPO/Gaz/E.C.Railway, Hajipur within 03 days from the date of written examination. In case of failure to comply the above instructions by the candidate, he/she will not be allowed to appear in the absentee written examination, if held.
3. The above selection will be based on candidate's performance both in written examination, viva-voce and Record of Service. The candidates, who qualify in the written examination followed by medical test in requisite medical category will only be eligible for viva-voce test. The placement of the candidates in the panel will be based on their performance in the written examination, viva-voce and record of service as per extant instructions of Railway Board.
- 3.1 The cut-off date of eligibility for candidates both for 70% selection and corresponding 30% LDCE (to be notified later) is 01.11.2018.
4. The main list of candidates of Operating Department who are eligible to appear in the Written Examination to the post of AOM/Gr.'B' against 70% quota and a stand-by list are enclosed and marked as Annexure-'A' and Annexure-'B' respectively in order of seniority.
- 4.1 Representation, if any, against the seniority position, omission/commission of any name may be sent to Dy.CPO/HRD through proper channel with a copy directly docketing to Dy.CPO/Gaz/ECR/HJP within 15 days from the date of issue of this notification. No representation will be entertained after the stipulated time period in any circumstances.

The Controlling officers should give wide publicity to this notification amongst the eligible staff under their control and ensure submission of willingness/unwillingness in prescribed proforma (Annexure 'C') from all the eligible candidates enlisted. The willingness/unwillingness of all the candidates enlisted in Annexure 'A' & Annexure 'B' may be sent to their Controlling Officer within the stipulated time. The last date for submission of willingness/unwillingness by the eligible candidates duly countersigned by their Controlling Officer is 09.07.2019.

5. All Sr.DPOs/Personnel Officers of the divisions/Units are requested to ensure that the Welfare Inspector/Personnel Inspector/Sectional Personnel Inspector should be deputed to obtain willingness/unwillingness in the prescribed proforma enclosed as Annexure-'C' from the candidates (including staff on deputation/leave/sick) of Annexure 'A' & Annexure 'B'. If any candidate refuses to submit willingness/unwillingness, the deputed Staff Welfare Inspector should submit a written report regarding non-submission of option by such candidates and he will be treated as unwilling for the said selection.

Above exercise should be completed within the target date and all the relevant papers (willingness/unwillingness) should reach to Dy. CPO (Gaz.)/ECR/HJP by 15.07.2019 positively, so that a final list of eligible willing candidates may be published.

The Controlling Officers are also requested to co-ordinate with the Personnel Officers and staff to complete the above exercise within time frame so that a final list of eligible candidates can be published within the time limit.

6. **Syllabus:** As instruction issued by Railway Board vide RBE No. 53/2019, the written examination shall comprise of one Paper which shall have 100% objective type Multiple Choice Questions only. The paper will be of 100 marks and the distribution of marks will be as under:

- a) Technical Subject including Official language policy : 70 Marks
- b) Establishment and Financial rules : 30 Marks

Qualifying marks will be 60.

All Objective type questions will carry equal marks. There shall be negative marking for incorrect answer. One-third (1/3) of the marks allotted for each question will be deducted for every wrong answer.

Question worth 10% of total allotted marks will be on the subject of Official Language Policy and Rule. which will not be compulsory to attempt. Since the post of AOM is safety category, hence no relaxation is admissible to SC/ST candidates as per extant rules.

As per IREM Vol-1 Para 204.2, no syllabus has been prescribed.

The question paper will be bilingual i.e. Hindi & English as per extant instructions. However, it will be candidate's choice to write in English or in Hindi.

7. TRAINING OF SC/ST CANDIDATES:

It may be noted that before conducting written examination, mandatory Pre-selection coaching classes of 3-4 weeks (21 working days) for SC/ST eligible candidates in terms of Railway Board's letter No.E(MPP)96/3/23 dated 21.07.2000, is scheduled to be held from 24/06/2019 to 19/07/2019 at ZRTI/Muzaffarpur. PCOM will nominate the in-charge of Pre-Selection Coaching. The In-charge will also intimate the date and venue of the pre-selection coaching in due course.

If any SC/ST candidate refuses to undergo pre selection coaching, a written undertaking should be obtained from him. The controlling officers should ensure that the SC/ST candidates under their control are spared without fail well in time to participate in the coaching. The SC/ST candidates are also advised to insist their controlling officers, in their own interest, to spare them for the said coaching.

7.1 Duty of the in-charge of Pre-Selection Coaching (To be nominated by PCOM):


- i) To inform in writing through special messenger to the concerned SC/ST employee with details of date, time & venue of coaching.
- ii) To obtain in writing unwillingness for coaching, if any, from the concerned SC/ST employees.
- iii) To arrange sparing of the candidates in case any problem occurs.
- iv) To chalk out coaching schedule.

7.2 Duty of Controlling Officer:-

To spare the candidates under their control without fail well in time with the direction to participate in the pre-selection coaching as well as to appear in the written examination also.

7.3 Duty of concerned SC/ST applicant:-

- i) To manage their sparing from duty by insisting their controlling officers in their own interest.

- ii) If any problem occurs in sparing, the candidate should report in writing to concerned In-charge of Pre-Selection coaching on the same date. No representation will be entertained in case of failure to report to the concerned In-charge of pre-selection coaching and it will be deemed to be refusal for the same.
- iii) Failure of concerned SC/ST employees to avail pre-selection coaching on any account including leave etc. will be considered on their own part.
- iv) No appeal will be entertained by GM(P)/ECR office after completion of pre-selection coaching.

After completion of coaching, the In-charge of the pre-selection coaching will give a written report along with all supporting papers including attendance sheet of SC/ST participants to Dy.CPO/Gaz/HJP within three days after completion of pre selection coaching for records and further action.

8. The controlling/authorized officer should ensure issuance of individual sparing letter/identity slip duly attested specimen signature of the candidate on the sparing letter/identity slip. The candidates without proper sparing letter/identity slip will not be allowed to appear in the examination.
9. Concerned Personnel Branch Officer & controlling officers should ensure submission of service records and ACRs/APARs and DAR/Vig Clearance in respect of staff declared qualified for the viva-voce in due course immediately after publication of the result of written examination through special messenger to Dy./CPO/GAZ/ECR/HJP.
10. The above selection will be held as per procedure laid down in master circular 68 governing promotion from Gr. 'C' to Gr. 'B' issued by Railway Board and the instructions issued time to time. The said master circular is available on website www.indianrailways.gov.in..>ministry of railway..>railway board..>Directorate...>Establishment...>E(GP) Master Circular. The department/division/unit should ensure the compliance of instructions of item 15 of Master Circular 68.




