**Part A:- CONDITION FOR RE- ENGAGEMENT OF RETIRED RAILWAY PARA-MEDICAL STAFF ON MONTHLY REMUNERATION BASIS.**

Re- Engagement of Retired Railway Employees who are below the age of 65 years as on the date of Notification (cut off date) on monthly remuneration Basis will be considered.

The retired staff desirous of re-engagement may attend for "WALK- IN- INTERVIEW", with the following document alongwith the prescribed format (Annexure-1) at the fixed venue/Time. They will have to appear before the committee to determine their suitability for the job:-

The re-engagement is subject to the following conditions:-

1. The scheme is valid up to 01.12.2019 (Ref.-RBE 193/2017)
2. The re-engagement is being made in the exigencies of service for a specific period of time.

**The re-engaged staff is liable to be terminated in any one of the following conditions:-**

- (a) On attaining the age of 65 years of age or on completion of the validity of the scheme i.e 01.12.2019 or at the end of the specific period of time whichever is earlier.  
Or
- (b) Till the vacancies are filled up by the regularly selected candidate through RRB/RRC/Departmental tests,  
Or
- (c) At any point of time when the Administration feels there is no further exigency to resort/continue re-engagement of retired staff.  
Or
- (d) In case the work/conduct of the re-engaged staff is not found satisfactory during such re-engagement.
- (3) The re-engagement shall be subject to the ex. Employee being medically fit for the post and being adjudged suitable by the nominated committee but shall not be automatic.
- (4) Monthly remuneration of a retired employee being re-engaged will be determined by Reducing pension from his/her last pay down (i.e.Basic pay+DA). The re-engaged employee are not entitled for any other benefits or facilities except the monthly remuneration.
- (5) The duty hours of the re-engaged employee would be prescribed by the concerned Branch Officer as per the working conditions of the post. Re-engaged employee shall be on duty on normal duty hours followed by the office in which they will be posted. The duty hours can be changed as per the requirement of work by the administration. They will be eligible for weekly off and general holidays observed by the office in which they will be posted. The re-engaged employee will not be eligible for any kind of leave (like CL, RH, LAP, Sick Leave etc.). For absence if any, appropriate deduction will be made from the monthly remuneration.

### OTHER TERMS AND CONDITIONS:-

- a) The initial engagement of the selected candidate will be purely on contract terms of maximum period of one year subject to continuation of the scheme beyond 31.03.2020 or till the vacant posts are filled up by RRB candidate whichever is earlier. The engagement of the above candidate is a stop gap arrangement and will not count as a service. Extension beyond 31.03.2020 will however, be subject to continuation of validity of the scheme by Railway Board.
- b) The minimum working hours are 08 hours per day that may include day/night or day-cum night as per exigency of service.
- c) The rest/weekly off may be on different day, not necessarily on holidays, etc.
- d) All the candidates should have good physical sound mental conditions as per Railway Medical Standards and they will be subjected to medical examination as per extant Railway Rules and those who are found fit in the prescribed medical examination will be engaged on contract terms.
- e) Candidate selected will has to undergo preliminary professional evaluation, and verification of required documents by committee of officers nominated by Competent Authority.
- f) In case of unsatisfactory work or misconduct on the part of the personnel so engaged on contract basis, Railway reserves the right to terminate the contract at any time without assigning any reasons thereof.
- g) No Railway accommodation and other benefits will be provided to the above candidate at par with the other Railway staff.
- h) The candidates on contract are required to follow the dress code as per Administrative requirement at their own cost.
- i) The candidate will have no prescriptive right to continue for the given period in the Notice. Their continuance in the Railways will be subject to their overall performance.
- j) The candidate has no right for automatic regularization or absorption in the Railways.
- k) The contract will be ceased on completion of the periods as specified at item "a" above automatically without issue of any notice etc.

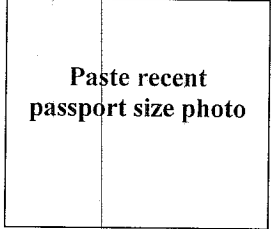
