
Applications of 03 candidates who applied in reference to the Notification dated 02.04.2019 for re-engagement as Consultant against Junior Scale vacant posts have provisionally been found in order. Accordingly, candidates of enclosed list (02 candidates) are advised to appear before the Selection Committee on 09.07.2019 for Interview as per programme given below so that suitability/competency for re-engagement may be adjudged:-

Candidates are advised to appear in the Interview as per above schedule along with original documents mentioned in the Notification and come prepared to stay for one or more days as Medical Exam will be held on next day.

On being found suitable in all respect for engagement, the engagement will be subject to the following terms & conditions:

1. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
2. The period of engagement shall be initially for one year and further extendable as per requirement.
3. Maximum age limit of the re-engagement shall be 65 years.
4. The engagement of Consultant shall not be considered as a case of re-employment.
5. 12 days leave in a calendar year on pro-rata basis is admissible.
6. Re-engaged officer shall not be entitled for requisites such as HRA, CCA, Transport Allowance, Residential accommodation, etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
7. The designation shall be consultant followed by (trade name) e.g. Officer appointed against the post of ADEN may be designated as Consultant (Engg.).
8. The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
9. Re-engaged officer shall be discharged immediately on joining of selected candidate(s) from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
10. Re-engaged officers shall be given responsibilities like inspections, supervisions, drawing etc. Detailed day to day duty list shall be prepared by respective PHODs and the re-engaged officers shall work under the guidance and command of assigned Controlling Officer.

11. Re-engaged officers shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
12. The administration will have the right to transfer re-engaged officers within jurisdiction of ECR in Administrative exigency.
13. In terms of Rly. Bd's letter dated 20.12.2018 in reference (i), retired officers upto Sr. Scale (not above senior scale) may be considered for re-engagement against the Junior Scale post, if willing to be re-engaged, on the same terms and conditions as issued for Re-engagement of retired Gazetted Officers in exigencies of services vide Railway Board's letter No. 2018/Trans Cell/S&T/Contractual Staff Dated: 25.10.2018, except the remuneration.
14. Monthly remuneration of a retired Senior Scale Officers being re-engaged against the Junior Scale post be determined by reducing Pension from his/her last pay drawn (i.e. Basic Pay + DA) by the officer in Junior Scale/Group 'B' just before the promotion to Senior Scale minus the pension of the retired officer. In case the last working of the retired Senior Scale Officer, re-engaged, in Junior Scale/Group 'B' post, was during VI CPC, then the corresponding amount can be worked out by applying 2.57 fitment factor and notional placement in the corresponding pay scale to ascertain corresponding VII CPC pay.
15. This scheme is experimental in nature and valid for 2 years from the date of issue of Railway Board's letter dated 25.10.2018 in reference (1).

No call letter shall be sent through post. E-call letter shall be sent through mail and intimation shall be given on mobile number also as mentioned in individual applications. The eligible candidates can print the E-call letter and appear in the Interview. Sample of E-call letter shall also be uploaded on ECR's website (www.ecr.indianrailways.gov.in) which can be printed.


