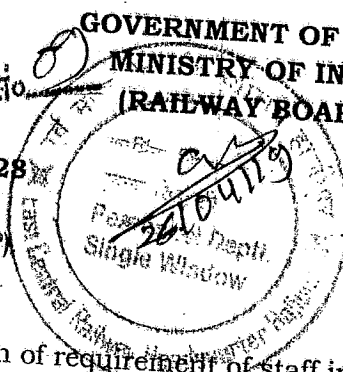

Sub: Inclusion of requirement of staff in PSUs on deputation in the assessment of vacancy of recruitment being made by Zonal Railways.

Railways PSUs are largely dependent on officers and staff from Railways on deputation for manning their projects. However, Railways often cite vacancies, especially of technical supervisors, as the reason for their inability to spare officials on deputation to these Railway PSUs. This not only impacts work in these PSUs, but is also cited by them as the reason for not releasing deputationists at the end of their sanctioned tenure of deputation.

Reling

2. To obviate the above problem, Zonal Railways are advised to factor stated requirements of Railway PSUs-especially in technical supervisory posts, while undertaking vacancy assessment for placing of RRB indents. Such inclusion in the assessment may be done based on firm requirements/projections from PSUs. As far as RVNL is concerned, the existing requirement of RVNL for three technical departments (Civil, Electrical and Signals) prepared department wise and railway wise for the next three years sent by them is enclosed. Zonal Railways may co-ordinate with other Railway PSUs as relevant, for similar assessment requirements with regard to their Railway.

3. With the finalization of the ongoing JEs recruitment notified in 2018 by RRBs, vacancy position of technical supervisors should ease considerably in Railways and sparing to RVNL and other Railway PSUs may therefore be considered by Railways to the extent feasible.
