


Sub:- Avoidable delay in selections.

Reeling

During a vigilance investigation of a complaint on aspect of delay etc. in a selection after the notification, it was found that less than ninety employees have submitted their applications for appearing in the examination till due date. However, a period of more than three months was elapsed in adjudging the eligibility of candidates. Further, in spite of clear instruction for arranging pre-promotional training for SC/ST candidates, it could not be arranged in time and it took almost seven to eight months to complete training course of three/ four weeks duration.

Finally the selection process was cancelled owing to restructuring orders issued by Railway Board. Had this selection been finalized timely, it would not have attracted cadre restructuring provisions.

In view of the above all concerned may be instructed to follow the selection calendar scrupulously to avoid such delays in selections.
