All the above named staff may be given independent duty after testing (a) Driving skill (b) Knowledge of road-learning (c) Brake-application during foot plate and other conditions as laid down in E.Rly Sl.No. 36/96 (RBE 40/96) dated 01.05.96 and RBE No. 101/2008 dated 22.08.08.

In pursuance of modified interim order passed by Hon'ble CAT/ALD in OA No.1286/2015 as also in view of the instructions obtained from GM(P)/HJP's vide their letter No. GM(P)/ECR/Misc. dated 16.08.2017, filling up the reserved vacancies can not be done because of the interim order of Hon'ble CAT/ALD and further action will be taken after getting final out come /orders of Hon'ble CAT/ALD in OA No. 1286/2015.

The posting order is provisional subject to final outcome of pending Contempt Petition (C) No. 314/2016 and SLP (C) No. 4831/2012 before Hon'ble Supreme Court.

Sl. No. 18, Sri Nayan Kumar, Sr.ALP/HZBN has been posted at HZBN under CCC/HZBN on spouse ground.

Sl.No. 1,2,5,6,13,15,17,21,22,23,29 & 30 have been transferred on promotion on administrative ground , as such, they are eligible for transfer pass, CTG, Joining leave and other facilities as per extant rule.

If Sl.No. 1,2,5,6,13,15,17,21,22,23,29 & 30 is in occupation of any Rly.Qtr at their present place of posting, they should vacate the same while carrying out the transfer orders, failing which damage/panel rent will be recovered from their salary and also D&AR action taken against them for unauthorised retention of Rly.Qtr. However, in this connection instructions as laid down in this office letter no. 118/E/ Ruling/ Rly.Qtrs. / 08 dated 04.07.08 may be followed.
