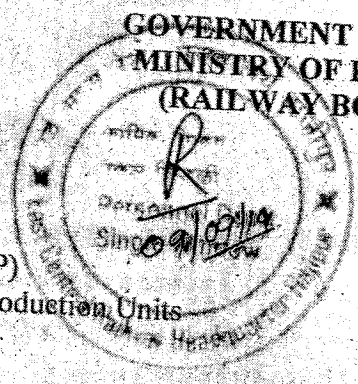

**Sub: Tenure of Deputation of Non Gazetted staff of Railways in Railway PSUs and autonomous bodies - Guidelines Regarding.**

The need for ensuring that Railway servants sent on deputation do not overstay and report back to their parent Railway on time has been reiterated several times in the past. Board's letter of even number dated 31.01.2019 is the latest such reminder in this regard.

- It has however been seen that non-gazetted staff are continuing on deputation with PSUs beyond the prescribed/sanctioned tenure of deputation with proposals being sent for post-facto sanction. This has been viewed seriously.
- While adhering to extant instructions on the subject therefore to prevent overstay of Railway employees on deputation, Railways are advised not to convey approval/ NOC at their end to the PSU concerned for any extension of deputation beyond the 5<sup>th</sup> year, unless Board makes a specific reference in this regard with respect to such NOC.
- This may kindly be circulated to all concerned within the Railway for strict compliance.
