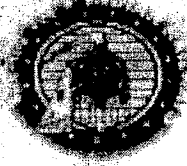

New Delhi, the 16th September, 2019

No. 2019/E&R/1(3)/1—It is hereby notified for general information that keeping in view the operational requirements Central Government has decided to revise the jurisdiction of Mysuru Division, Bengaluru Division and Hubballi Division of South Western Railway as under:

- (i) The section between Mysuru to Yeliyur (30.15 kms from 131.85 to 101.70) is transferred from Bengaluru Division to Mysuru Division and the new divisional boundary between these two divisions will be at 101.700 Km.
- (ii) The section between Tumakuru to Sampige Road (39.80 kms from 70.50 to 110.300) is transferred from Mysuru Division to Bengaluru Division and the new divisional boundary between these two divisions will be at 110.300 Km.
- (iii) The section between South Hubballi to Karajgi (62.70 kms from 463.00 to 400.30) is transferred from Mysuru Division to Hubballi Division and the new divisional boundary between these two divisions will be at 400.300 Km.
- (iv) The section between Kotturu to Amaravathi Colony (59.30 kms from 135.00 to 75.70) is transferred from Hubballi Division to Mysuru Division and the new divisional boundary between these two divisions will be at 75.700 Km.

The changes in the above jurisdiction will come into effect from 1st October, 2019.
