

Sub: Merger of Level-1 Staff of Signal & Telecom Wings of S&T Department.

Board's letter No. PC-VI/2009/1/1/3 (Vol.II) dated 27.12.2018 (circulated under RBE No. 201/2018) on revision/rationalization of the designations of various erstwhile Group 'D' (present Level-1 categories) may be referred to. It may be noted that Para-3 of the said letter enables merger of seniority groups too, wherever designations of Level-1 (erstwhile Group 'D') are merged. Such decision regarding merger of erstwhile separate cadres/seniority groups (including in a phased manner) is however a decision to be taken by the Railway/field unit concerned, based on local conditions and in consultation with recognized unions in all such cases, as mentioned clearly in the letter referred to.

2. In respect of the Signal & Telecom Department, the list of revised Level-1 (erstwhile Group 'D') designations annexed with the letter already provides for a common designation of Assistant (Signal & Telecom) for the erstwhile Group 'D' categories of Helper-Gr-II & Gr-I (Signal) and Helper Gr-II & Gr-I (Telecom).

3. Keeping the above background in view, and considering the functional and operational desirability of having a common pool of Level-1 staff in the Signal & Telecom wings of the Signal & Telecom Department, Railways may like to take this matter forward in respect of Level-1 employees covered under the common designation of Assistant (Signal & Telecom). Status report/action taken in the matter may be intimated to Board's office.
