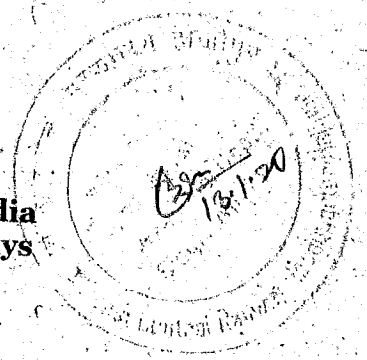

Ref:- WR's letter No. PEN/05372/E789/ARPAN/PRE-2016/Re grant/Fam.Pen dated 01.01.2020.

A new module namely "Re-grant family Pension" has been developed and deployed in ARPAN to enable issuance of PPOs to family pensioners of pre-2016 pensioners (other than spouse) viz., dependent unmarried/ widowed/divorced daughter, physically handicapped child/mentally disabled child. Further details with regard to access to this menu and processing of cases in this menu has also been furnished along with a specimen PPO (copy enclosed). It may be noted that the existing procedure for sanction and issuance of such PPOs should be scrupulously followed.

Sub: Re-grant of Family Pension to dependant family member: Pre-2016 cases

In order to facilitate railways for fresh authorisation (Re-Grant) of family pension in favour of dependant family member (other than spouse already been included in PPO), a utility i.e. "Re-Grant Family Pension" has been developed and deployed in ARPAN.

The scheme inter alia covers family pension cases of eligible dependent unmarried daughter/widowed daughter/divorced daughter/physically handicapped child/mentally disabled child etc. of pre-2016 pensioners alive as on 01-01-2016 where revised PPO (for parents) has already been generated exclusively in ARPAN but the pensioner/family pensioners (parents) has deceased subsequently.

The utility i.e. "Re-Grant Family Pension" is available to PL1 users under "Revision (Pre-2016)" Menu for initiating and processing of authorisation of family pension in favour of the aforesaid claimants.

The 14 digit ARPAN PPO number of Pre-2016 pensioners is mandatory for populating and validating the existing legacy data in the system. In the event of non-appearing of claimant's name in ARPAN against the Pre-2016 ARPAN PPO, the user needs to add and validate the beneficiary details before initiating the case for authorisation of PPO.

While adding the name of the claimant/authorising family pension, the eligibility criteria as prescribed by Railway Board from time to time must be ensured with reference to supporting valid documents. The User also needs to upload the scanned JPEG/PDF image of claimant's Photograph, Date of Birth and other mandatory documents in to the system depending upon the status of the claimant.

After completion of the process by PL1, the physical file along with required documents and system generated data-sheet, must be submitted to the concerned PPO issuing authority for issue of fresh PPO. The PPO number will remain same as already generated in ARPAN in favour of deceased pre-2016 pensioner/family pensioner but will contain the claimant's details, authorised family pension amount, date of commencement of payment and disbursing bank particulars.

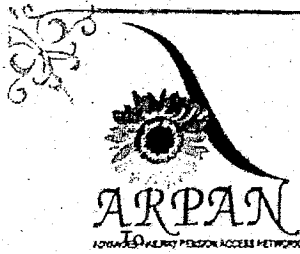
Before issuing such re-grant PPOs, it may also be ensured that the closed PPO of deceased Pensioner/family pensioner has been returned by the bank with last paid certificate and excess payment if any has been remitted back to railways.

Instructions may be issued to the concerned USERS to process the cases of above nature through ARPAN instead of AFRES/ITAS/local programme/Manual system, so that 14 digit PPO number can be invariably assigned to such cases for effective handling of e-PPO, e-reconciliation, UMID registration and Grievance management etc.

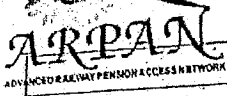
