Applications in sealed envelope are invited from suitable vendor/suppliers/firms for supply of medicines,surgical and consumable items under retail local purchase for Divisional Railway Hospital/ECR/Sonpur in terms of PCMD/HJP's letter no.ECR/Med/RMC/Vig.dated 03.01.2020.

The supplier/vendor/firm should have the following minimum eligibility criteria for consideration of their request to supply the medicine, surgical & consumable items for the period of two (02) years.

- (1).The supplier/vendor/firms retails outlet should be located in Sonpur, preferably in the vicinity of Div.Rly. Hospital,Sonpur.
- (2) . The supplier/vendor/firms should have technical,Legal and and financial eligibility and capability.
 - . Technical Eligibility :-Presence of competent,qualified and trained manpower i.e Pharmacist.
 - . Legal : Having a valid Drug Licence along with pan no.and GST of proprietor.
 - . Financial : Last three years turnover document vcertified by a CA. /ITR documents
 - . Performance certificate by last institution where the supplier/vendor/firm has been working since three years .
 - . Address a request for registration to CMS/SEE/ECR.
 - . The supplier /vendor/firms have to offer a discount on MRP (Separately for medicines,surgical and consumables).The vendor who offers maximum discount,will be awarded the contract for supply of aforementioned items for the period of two years.

The following services are required to fulfil by the supplier/vendor/firm with following modalities:-

1. After receiving the order by any means i.e physical handover/fax/email/electronic media or platform, the supplier has to supply the medicine on same day/earliest as possible depending on the time of receiving or nature of gravity of medicine.
2. The vendors should supply the same name and composition as per indented order.No alternate or substitute medicine will be allowed without the permission of CMS.
3. Any flaw in delivered item or failure of supply will be dealt as per Railway Board letter no.2014/RS(g)/79/13 dated 04/06/2018
4. The sufficient stock should be maintained so that the promptness of supply is ensured.The working services required is on the basis of 24 x 7.

The interested suppliers/vendors/firms fulfilling the above criteria should apply to the Chief Medical Superintendent, East Central Railway, Sonpur,Post office-Sonpur Dist.Saran,Pin code-841101 with full description of the their institution as asked above for the purpose of short listing and empanelment of supplying the medicine , surgical ,consumable items to Divisional Rly.hospital , Sonpur within 15 days from the date of advertisement .
