

“Online Interview” for engagement of General Duty Doctors and Specialist Doctors for three months only on contract basis (For Retired Doctors only).

1. “Online Interview” will be conducted by East Central Railway for engagement of full time General Duty Medical Practitioner/Specialists for Central cum Super Specialty Hospital/Patna. Willing Doctors who fulfill the qualification/eligibility criteria specified below may apply for the above engagement. The engagement will be purely on Contract basis for the period of **three months only**.
2. **GDMO/Specialist Doctor (Full time) for the period of 03 (three) months only in terms of Railway Board’s letter no. 2020/E(GR)II/COVID-19/WFH/1 dated-28.03.2020 & 31.03.2020 against over and above vacancy.**
3. **Specialists Doctor & GDMO (Full time)**

(B) Qualification for Specialists:

- (a) Degree/Diploma in corresponding specialty mentioned above in remarks column.
- (b) Should be registered with Medical Council of India/Medical Council of State.

(C) Qualification for GDMO :

- (a) MBBS degree.
- (b) Registered with Medical Council of India/Medical Council of State.

4. Only Retired IRHS officers, Retired Government Medical Officers of State Government and Central Government and PSUs may apply against above vacancies. The condition will be as under:-

(i) **Age:-** Not exceeding 65 years as on 29.06.2020.

(ii) **Qualification:-** Degree/Diploma in *corresponding specialty* mentioned in remarks column above for Specialty and for GDMO, the minimum qualification required is MBBS.

(iii) **Remuneration:-** Fixed remuneration of Rs.75000/- (Seventy five Thousand only) per month for GDMO & Rs. 95000/- (Ninety-five thousand only) per month for Specialist, subject to condition that remuneration + pension should not exceed the last pay drawn by Retired Doctors.

(iv) Terms and condition will be followed as mentioned in Railway Board’s L.No:2008/E(GR)II/1/1 dated-16.07.12,Rly.Bd’s L.No-2013/E(GR)II/1/5 dated-20.05.14 & 09.07.2018, Rly. Bd’s L.No.2020/E(GR)II/COVID-19/WFH/1 dated-28.03.2020 & 31.03.2020..

NB : The retired Railway Doctors who are below 65 years may be given first preference for engagements against above vacancies.

5. How to apply & Mode of Interview:-

- (I) Candidates intending to join as Contract Medical Practitioner should apply on prescribed format (attached) and send the scanned copy (in pdf format only) of their application (duly filled and signed) through e-mail along with copy of requisite documents/certificates as mentioned in the para II below.

Application received after above date & time will be rejected summarily.

(II) Document required (copy to be scanned in pdf only and attached in email)

- (a) Proof of age. (10th class pass certificate)
- (b) Proof of passing MBBS (with all year/semester wise marks sheet), Internship, Degree, Diploma & other educational qualifications.
- (c) Proof of registration in Indian Medical Council/Medical Council of State.
- (d) Experience certificate if any.
- (e) Mark Sheet(s) of relevant qualification(s).
- (f) Pension Payment Order.
- (g) Service Certificate issue by Organization on Retirement, if available.

- (III) Date and time for interview through Video conferencing: The shortlisted candidates will be subjected to interview through Google meet/ Whatsapp/Zoom App Call. Date of interview will be intimated through e-mail & official website of E. C. Railway. Candidates are advised to have a laptop/smartphone (with internet connection with audio & Video facility) with them & install **Whatsapp/Zoom App/Google meet** for Videoconferencing.

- (IV) Candidates must mention **e-mail id & Active Mobile No. on their Application form** for Calling/Whasapp Video/Audio Call & intimation of date and time of interview.

- (V) After interview, provisionally shortlisted candidates will be issued provisional offer letter & called for Document Verification and Medical Examination, in which candidates should submit all original as well as self-attested copies of certificates mentioned in Para-5(I) above. After found fit in Document Verification, other formalities of engagement as CMP will be done. If the candidate will not submit requisite documents during Document Verification his candidature will be summarily rejected.

- (VI) All future communication will be done through e-mail or official website of E. C. Railway. Hence, candidates are advised to regularly visit the official website of E. C. Railway for any update. Official website of E. C. Railway is www.ecr.indianrailways.gov.in (Click Hajipur HQ>Personnel>Recruitment/Selection Notification)

6. General Conditions and other facilities:-

- (a) Selected candidates will be posted at Central cum Super Specialty Hospital, East Central Railway/Patna. The Vacancies announced are only indicative and Railway reserve the right to make adjustments.
 - (b) The engagement is for posting in CSSH/Patna. However, in exigencies of services, the engaged CMPs can be posted anywhere over E. C. Railway.
 - (c) Contract Medical Practitioner can avail free medical treatment on E.C.Railway Hospital for self only.
 - (d) In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
 - (e) CMP will have no right of posting against regular vacant post or transfer on request.
 - (f) CMP is not be allowed private practice after sanction of contract.
 - (g) There may be change in numbers of vacancies and place of posting as specified above depending upon administrative requirement. Offer of posting will be made on the basis of availability of vacancies at the time of engagement.
 - (h) Posts indicated herein may be kept unfilled at the discretion of Railway administration.
 - (i) Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service. The service rendered as CMP will not confer the right to take waitage for regular selection through UPSC and also will not confer any right for regularization or absorption.
 - (j) If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to afresh entrant to Group 'A' Junior Scale/Sr.Scale and license fee of the Railway accommodation will be deducted from the monthly remuneration payable to the Contract Medical Practitioner.
 - (k) In case Specialists are not available against the vacancies as notified, Railway Administration will reserve the right to engage Specialist of alternate Specialty against these vacancies.
 - (l) Offer of engagement will be issued in favour of selected candidates. The candidates should report within 7 days from the date of issue of offer letter. For candidates not reporting within stipulated time, offer may be cancelled.
 - (m) Contract of the CMPs can be terminated by the Railway at any time during the contract period by giving 7 days notice without assigning any reason as per the terms and condition laid down in Railway Board's L.No:2007/H/1/1 dt-16.10.08; L.No:96/E(GR)II/9/16 dt-23.02.2000; L.No:2013/E(GR)II/1/5 dt-20.05.14; L.No.2014/E(GR)II/1/1 dt-13.06.17 & Rly.Bd's L.No 2018/Terms.Cell/Health/Medical Issues dated-24.08.2018
