**Sub: Coverage under Central Civil Services (Pension) Rules, 1972, in place of National Pension System in terms of DoP & PW O.M. dated 17.02.2020 and Railway Board's RBE No. No-28/2020 dated 03.03.2020.**

Ref.:- Writ petition (C) No.- 10288/2019 filed by Sh. Dindayal Jangir & 56 others against UOI & others before Hon'ble High Court of Delhi

**File No.ECR-HQOPERS(RULE)/48/2020-O/o Dy.CPO/HQ/ECR**

A Writ petition (C) No.- 10288/2019 was filed by Sh. Dindayal Jangir & 56 others Public Prosecutors of Indian Railways before Hon'ble High Court of Delhi to get benefit of Old Pension Scheme in place of National Pension System. The case was heard on 30.09.2019 and Hon'ble Delhi High Court passed an order in favour of the petitioners, which is as under:

*".....On the same analogy in the present cases, the writ petition is allowed and a direction is issued to the respondents to extend to each of the petitioners the benefit of the OPS and pass all consequential orders in that regard within a period of 04 weeks from today. The arrears should be paid to each of the petitioner within 12 weeks failing which each of them would be entitled to simple interest at 6% per annum on the sum constituting the arrears for the period of delay...."*

2. In this connection, it is apprised that recruitment for the post of Inspectors (Prosecution) Gr.-II in RPF was conducted by Railway Recruitment Board/Chandigarh vide Employment Notification No. RRB/CDN/EN-02/2002 dated 07.12.2002. A Panel of 73 selected candidates was approved by DG/RPF and the final result was declared on 22.08.2003. All the petitioners were placed in the select panel amongst the empanelled candidates. It was further informed by Railway Recruitment Board (RRB) that the offer of appointment would be issued by the then Chief Security Commissioner/RPF of concerned Zonal Railway. At the time of issuance of the said Employment Notice in the year 2002, Old Pension Scheme under the Central Civil Services (pension) Rules, 1972 was in vogue.

3. The issue to extend the benefits of old pension scheme to all the petitioners has been examined at Security Directorate Railway Board in consultation with DG/HR, E(GC), E(GR) & F(E) Branch Railway Board and it has been advised that the instant cases may be examined by the appointing authority duly keeping in view the stipulations of DoP & PW given in O.M. dated 17.02.2020 and take a decision."


4. Since, all 73 candidates (including 57 petitioners), recruited for the post of Inspector (Prosecution) Gr.-II in RPF vide Employment Notification No. RRB/CDN/EN-02/2002 dated 07.12.2002 are eligible for coverage under the CCS (Pension) Rules, 1972 in terms of DoP & PW's O.M. dated 17.02.2020 and Railway Board's RBE No-28/2020 dated 03.03.2020.

Hence, it is kindly requested that necessary action may be taken regarding coverage under Central Civil Services (Pension) Rules, 1972, in place of National Pension System in respect of the all candidates (including 57 petitioners), recruited for the post of Inspector (Prosecution) Gr.-II in RPF vide Employment Notification No. RRB/CDN/EN-02/2002 dated 07.12.2002 and working at your respective Zonal Railways in terms of DoP & PW's O.M. dated 17.02.2020 & 25.06.2020 and Railway Board's RBE No-28/2020 dated 03.03.2020 to avoid contempt of the Hon'ble High Court.

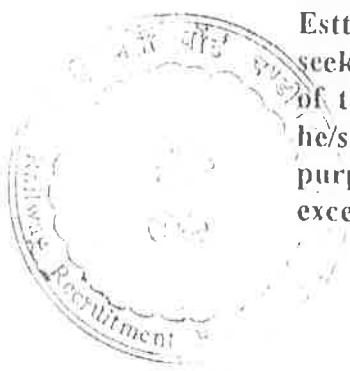
Allotment of Zonal Railway has been made on the basis of merit and candidates' preferences. The above candidates are being advised directly about their selection.

The merit list of selected candidates with all of their preferences for posting (in two sheets) and Zonal Rly. wise merit lists (in 11 sheets) also enclosed. Shortfall of 04 ST candidates is returned herewith.

**NOTE:** (i) In terms of Railway Board letter No.99/E(RRB)/26/6 dt.07.02.2000, it is advised that the candidates who have been Empanelled Provisionally should not be offered appointment unless they produce Original Degree/Certificate, or it is verified from the concerned university/examining body, that he has indeed passed the examination for which the marks sheets have been submitted by them".

(ii) "In terms of Railway Board letter No.2003-E(SCT)/71/2 dated 31.07.2003(RBE No.133/2003-Copy enclosed) communicating DOP & Ts O.M. No.36033/4/97 Estt.(Res.) dated 25.7.2003 "The appointing authority, before appointing a person seeking appointment on the basis of reservation to OBCs should verify the veracity of the community certificate submitted by the candidate and also the fact that he/she does not fall in creamy layer on the crucial date. The crucial date for this purpose may be treated as the closing date for receipt of applications for the post except in cases where crucial date is fixed otherwise."
