“Online interview” for engagement of Doctors on contract basis upto 30 June-2021

1. Online interview will be conducted by Danapur Division of East Central Railway for engagement of full time Medical Practitioner for Division Railway Hospital, Danapur. Willing Doctor who fulfils the qualification/eligibility criteria specified blow may apply for the above engagement. The engagement will be purely on contract basis upto 30 June-2021 or engagement may be extended as per required/instruction of Railway Board.
2. **Doctor (Full time) for the period upto 30 June-2021 in terms of Railway Boards letter No. 2020/E(GR)II/COVID 19/WFH/1dated 28/3/2020 and 31/3/2020 against over and above vacancy.**

Retired IRHS officers, Retired Government Medical Officers of Central/State Government and PSUs may also apply against above vacancies.

NB : The Retired Railway Doctors who are below 65 years may be given first preference for engagement against above vacancies.

The terms and conditions will be as under:

- (i) **Age limit:** The maximum age limit is 65 years as on 01/04/2021 for Doctor. The engagement of doctors is purely on contract basis up to 30 June-2021 or engagement may be extended as per required/instruction of Railway Board.
 - (ii) **Qualification:** Degree/Diploma in corresponding specialty mentioned in above column.
 - (iii) **Remuneration:** Fixed remuneration of Rs. 75000/ (Seventy five thousand only) per month. For retired Doctors that remuneration + pension should not exceed the last pay drawn.
 - (iv) Terms and conditions will be followed as mentioned in Railway Boards letter No. 2008/E(GR)II/1/1 dated 16/7/2012, Railway Boards letter No. 2013/E(GR)II/1/5 dated 20/5/2014, Rly Bds letter No. 2013/E(GR)II/1/5 dated 09/7/2018 and letter No. 2020/E(GR)II/COVID 19/WHF/1 dated 28/3/2020 & 31/3/2020.


5. **How to apply:**

- (a) Proof of age.
- (b) Proof of passing MBBS, Internship, Degree, Diploma & other educational certificate.
- (c) Proof of registration in Indian Medical Council/Medical Council of State.
- (d) Mark Sheet(s) of relevant qualification.
- (e) 04 (four) copies of passport size photograph with self signature.

In case of retired Doctors:-

- (a) Original Pension Payment Order book & self attested copy
- (b) Service Certificate issued by Organization on Retirement, if available.

6. General Conditions and other facilities:

- (a) Selected candidates will be posted at Divisional Railway Hospital, Danapur (Khagaul). The vacancies announced are only indicative and Railway reserve the right to make adjustment.
- (b) The engagement is for posting in Divisional Railway Hospital, E.C. Railway, Danapur, However, in exigency of services, the engaged CMP can be posted anywhere over Danapur Division.
- (c) Contract Medical Practitioner can avail free medical treatment on E.C. Railway Hospital self only.
- (d) No TA/DA will be paid to the candidates for attending the interview.
- (e) In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
- (f) CMP will have no right of posting against regular vacant post or transfer on request.
- (g) CMP will not be allowed private practice after sanction of contract.
- (h) There may change in the numbers of vacancy and place as specified above depending upon administrative requirement. Offer of posting will be made on the basis of vacancies available at the time of engagement.
- (i) Post indicated herein may be kept unfilled at the discretion of Railway Administration.
- (j) Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service rendered as a full time contract. The service rendered as a CMP will not confer the right to take weightage for regular selection through UPSC and also will not confer any right for regularization or absorption.
- (k) If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to afresh entrant to Group A Junior Scale/Senior Scale and license fee of the Railway accommodation so provided will be deducted from the monthly remuneration payable to the Contract Medical Practitioner.
- (l) Reservation policy will be applied as per rule.
- (m) Offer of engagement will be issued in favour of selected candidates must report within 03 days from the date of issue of offer letter. The candidates who do not report within stipulated time, their offer may be treated as cancelled.
- (n) Contract of CMPs can be terminated by the Railway at any time during the contract period by giving notice without assigning any reason as per the terms and conditions laid down in Railway Boards letter No 2007/H/1/1 dated 16/10/2008, Letter No. 96/E/(GR)II/9/16 dt. 23/2/2000, Letter No. 2013/E(GR)/II/1/5 dt. 20/5/2014 and Letter No. 2014/E(GR)/II/1/1 dated 13/6/2017.
