Notification

**Sub : Filling up the post of drafted supervisor for working as TLC (Level-6) at HJP Control (HQ) in electrical department.**

It is proposed to draft suitable running staff from the category of Loco Pilot to fill up the 04 (Four) existing vacancies of drafted supervisors for working as TLC at HJP Control (HQ) in electrical department on their existing pay and grade by conducting a screening in terms of instructions contained in Railway Board letter No. E(P&A)II/83/RS-10, dated : 09.01.1998 & E(P&A)-II-2007/RS-14 dated : 26.03.2009 (RBE No.51/2009).

**Eligibility :-**

- I. Suitable Loco Pilot (Mail/Express), Loco Pilot (Passenger) & Loco Pilot (Goods), Who have completed minimum 75,000/- k.m. actual foot plate duty as Loco Pilot are eligible to apply.

**Terms & Conditions :-**

- (i) The Staff drafted on being found suitable duly screened will be governed under the instructions circulated Railway Board letter No. E(P&A)II-83/RS/10 dated : 09.01.1998.
- (ii) They are not eligible for any benefits under scheme vide letter No. E(P&A)II/83/RS/10 dated : 25.11.1992.
- (iii) Their tenure will be for 03 years duration with a cooling off period with equal duration. They are eligible to progress in the running cadre subject to other terms and conditions of service as applicable to running staff including pay and allowances, peridical medical examinations, selection, suitability test, etc.
- (iv) Distinct scale of pay pertaining to TLC is abolished.
- (v) Seniority will not be the criteria for drafting the staff.
- (vi) The drafted Loco Pilots will be eligible for payment of allowances in lieu of KMs per day, at the rates applicable to them from which category they are drafted..
- (vii) Suitability and efficiency will be the criteria.
- (viii) There is no claim for TA & DA and special pay etc.
- (ix) The tenure rule of 03 years will not be applicable to medically decategorised staff drafted if they are suitable. However, if their performance is not found suitable they will be taken up under DAR and will be considered for alternative jobs following the rules applicable to medically decategorised staff.

- (x) In case of healthy drafted Loco Pilot, if performance as TLC is not found satisfactory, they may be taken under DAR and may be reverted back to their parent cadre.
- (xi) Seniority of the selected Loco Pilots will continue to be maintained at their parent unit and they will be eligible to further promotion in their parent unit on the basis of their seniority.

This should be given wide publicity amongst the staff and application from the willing and eligible staff to be send to this office latest by **10/07/2021**. In bunches and the same is to be verified & ensured regarding completion of 75,000/- KMs required actual driving experience in terms of RBE No.51/2009 in the proforma placed at Annexure "A" duly forwarded by concerning office/units and it should be ensured that the application once entertained may not be cancelled in future. Application received after target date will not be considered.

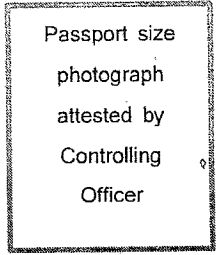
