Sub:-Formation of Panel of Junior Clerk in Level-2 from Level-1 against
33.33 % PR Quota-47(UR-37, SC-07, ST-03)

It has been decided by the competent authority to form a panel of 47 Post (UR-37, SC-07, and ST-03) against 33.33% departmental promotional quota of CG-II in Level-2 from amongst in Level-1. Accordingly applications from eligible Level-1 Staff are invited.

Eligibility criteria for 33.33% PR quota.

Staff of those category of Level-1 are eligible who have no regular avenue of promotion and more than two years continuous service (Excluding service of Casual/Substitute) as on 23.02.22. The service of Temporary status (TS) will also be counted for reckoning continuous service if it is followed by regular absorption in an eligible Level-1 post without interruption (RBE No.20/2003) As per RBE No. 157/15 the staff appointed on or after 17.12.14 must have passed 12th (+2 stage) or its equivalent examination with not less than 50% marks in the aggregate and also SC/ST/Ex-servicemen too. The staff having matriculation qualification appointment prior to 17.12.14 may also be considered to be eligible for selection. Further to include that the written test will be held on OMR sheet consisting 100% objective type question with optional 10% of Rajbhasha related questions.

The following staff are eligible for the above selection against 33.33%PR Quota) in terms of GM(P)/HJP'S letter No. E/Pers/254/ECR/Gr. "D" to "C" dated 24.01.12 & RBE No.03/2019 & GM (p)/HJP letter No.ECR-HQoPERS (SEL)/20/2020 Com. No.33205 dtd 16.2.2022.

Staff of those categories of Level-1 is eligible for consideration in the selection for promotion to Level-2 only on completion of two years regular service in the concerned seniority unit.

Categories- Peon, Jamadarpeon, Gestator Operator, Ferro printer, Xerox operator, Record shorter, Chowkidar (All department), Safaiwala/Jamadar safaiwala (All department), Hospital Attendant & Store/KH.

Note: - (a) Level-1 staff of Account Department and Security Department are not eligible for above selection.
(b) The designation as mentioned above in categories will only be treated as eligible if he fulfils the required conditions. The staff working on deputation or temporary basis is not eligible.
(c) The staff should fulfil the required minimum service period as per notification.

This should be given wide publicity amongst the eligible staff. Application in the proper form (Format enclosed) received by the eligible staff should be sent in bunch along with forwarding letter to Ch. OS/EO Section of personnel Branch/Dhanbad through special messenger so as to reach this office on or before **23.03.2022** all the application must be individually forwarded by senior subordinate/Branch officer. Application received after the stipulated date will not be entertained.

All the eligible staff/volunteers will be called for to appear in the written test and who will qualify in the written test will be eligible for final assessment for empanelment.

They will be posted in anywhere in the division to fill up the vacancies.

This is a selection for general post and as such there is no provision of holding continuation selection (supplementary) for the absentee those will be called for the selection must appear on the same and they will not be given another chance at any circumstance.

The Staff in Level-1 working in construction department and whose lien has been fixed in this division may also apply for the above selection.

It may also be made clear to all the volunteers that in case of them are found not be fulfilling the eligibility as laid down above at the time if subsequent scrutiny ,their candidature will be cancelled even if they are found suitable in the written test .

Staff appointed against department quota to the categories of Junior Clerk are required to possess type writing speed of 30 word per minute in English or 25 words per minute in Hindi within two years from the date of promotion and that their promotion will be provisional subject to acquiring the prescribed typing qualification within the stipulated period as per RBE No. 65/2000.
