Ref:- This office notification of even No. dated 31.05.2021.

To hold the selection to the post of Assistant Mechanical Engineer (Gr. 'B') against 70% quota, 04 vacancies (UR-03, SC-00, ST-01) have been notified vide above referred notification dt. 31.05.2201. For this, list of 30 candidates (15- Main list as Annexure- 'A' & 15- Standby list as Annexure- 'B'), as per seniority was circulated, but the adequate number of candidates have not expressed their willingness to appear in the said selection.
