In reference to this office letter of even no. dt. 05.05.2021, it is to inform that date of written examination for the above post which was scheduled to be held on 27.05.2022 is postponed due to administrative reasons and re-fixed to be held on 26.06.2022.

It has been decided by the competent authority to hold the above written examination at three centres i.e., **at DHN, BRKA and CPU on 26.06.2022** and allocated the jurisdiction of candidate viz GHD to Gomia to BRKA, Eastward to Dhanbad and Westward to Chopan.
