Engagement of Honorary Visiting Specialist (HVS) on contract basis.

In terms of GM(P)/ECR/HJP's file no.ECR-HQ0PERS(Gaz)/843/2020 dtd.10.02.2023, applications are invited for engagement of 02 Honorary Visiting Specialist (HVS) for Danapur division. Willing Doctors who fulfill the qualification/eligibility criteria specified below may apply for the above engagement. The engagement will be offered purely on contract basis for the period of one year, which can be renewed as a fresh contract on year to year basis for i.e. 02 years or till the validity of the scheme whichever is earlier.

1. Description of posts

2. Qualification :

- (a) Super Specialist- Minimum qualification will be Post Doctoral qualification DM/MCH or equivalent.
- (b) Specialist- Post Graduate Degree from a recognized university, Minimum 03 years experience in the professional work related to concerned specialty after obtaining PG Degree.
- (c) Where suitable candidates with PG Degree are not available PG Diploma holders with five years experience in the professional work related work to concerned specialty after obtaining PG Diploma.
- (d) Under no circumstances shall a specialist of any discipline other than the ones which were advertised be engaged

3. Age profile:

- (a) During first time engagement, the preferred age is between 30 years to 64 years.
- (b) Upper age limit of continued engagement is 65 years.

4. Tenure of working:-

- (a) Each time the offer is given, it is to be given for year only.
- (b) After expiry of 01 year, extension can be given subject to adoption for a transparent method based on the performance report to be recorded at a senior level by Medical Department with the approval of GM/ECR/HJP.

In addition they will have to come to Hospital whenever called in for emergency on any day including Sunday or off day.

5. With the implementation of this scheme, the Honorary Visiting Specialists will be given consultations & performing surgeries and other advice as required. They would be performing surgery also in the Railway Hospitals, and those cases which require referral and the condition of that patient such that is manageable during operation and post operating period in that Railway Hospital, will be referred to Private/Govt. Hospitals, for the specialty for which visiting specialists are available in the Railway Hospitals. It is further clarified that few high risk patients will still be required to be referred higher medical Centers.
6. Daily rate of deduction of remuneration:
They are allowed to have 12 days leave every year. For any absence beyond 12 days, deductions will be made at the following rate -

4 Hrs. a day for 6 days/week	Rs.3250/-	Rs.4000/-

7. Termination of contract:
- An HVS can tender her/his resignation by giving a 15 days notice.
 - Administration can also terminate the engagement of HVS by issuing a 15 days notice without assigning any reason therefore. However, in exceptional circumstance due to exigencies to service and administrative interest service of a HVS may be terminated with immediate effect. The decision of Administration in such cases will be final.
8. How to apply:-
Application intending to join as Honorary Visiting Specialist should apply on prescribed format (enclosed) and submitted the same directly to DRM(P)/DNR within 21 days from the issue of the notification with attested copies of certificates mentioned below -
- Proof of age.
 - Proof of passing Post Graduate Degree/Diploma & other educational certificate issued from recognized Institution/University.
 - Proof of registration in Indian Medical Council/Medical Council of State.
 - Mark Sheet(s) of relevant qualification.
9. General Conditions and other facilities:-
- In the event of absence from duty, deduction from the remuneration will be applicable as per para above.
 - Railway Administration has legitimate right to transfer the engaged HVS anywhere on E. C. Railway in case of administrative exigency.
 - One set of complementary Railway pass valid in AC two tier including Rajdhani Express and in AC Chair Car of Shatabdi Express for self+Spouse and dependent children (as per rules application for Railway employees) will be made available as per the entitlement of Selection Grade officers each calendar year.
 - The complementary pass can be availed after 3 months of engagement for the calendar year.
 - HVS will have no right of posting against regular vacant post or transfer on own request.
 - The candidates working in any Medical Organization/State Govt. should submit their application through proper channel with "No objection certificate".
 - Change of numbers of posts and place as specified above are subject to the condition.
 - Posts indicated herein may be kept unfilled at the discretion of Railway administration.
 - HVS engaged on contract basis in the Railway will not have any claim or right for his/her continue in service or automatic extension of the term of contract service. The service rendered as a HVS will not confer the right to take wait age for regular selection through UPSC and also will not continue any right for regularization or absorption.



- (j) Offer of engagement will be issued in favour of selected candidates, the candidates should report within 15 days from the receipt of offer letter. The candidates not reported within stipulated time, offer may be treated as cancelled.
- (k) Contract of the HVS can be terminated by the Railway at any time during the contract period giving 15 days notice without assigning any reason.
