

Applicants are requested to go through the following terms & conditions carefully for re-engagement.

TERMS & CONDITIONS FOR RE-ENGAGEMENT

1. Before applying for the post, the retired employees should ensure that he/she has retired from the category applied for and fulfils all other eligibility norms.
2. Retired employees applying for post should not have been covered under the Safety Related Retirement Scheme (SRRS)/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).
3. Their engagement is subject to medical fitness in the appropriate category.
4. Suitability/Competency of the retired employee will be adjudged before engagement keeping in view of earlier safety records.
5. The maximum age limit of the retired employees applying for the post is below 62 years and in no case it should exceed the maximum age of 62 years during the period of re-engagement.
6. The daily remuneration shall be paid in terms of Railway Board's guidelines issued under their Letter NO.E (NG) II/2007/RC-04/CORE/1 dated 11.12.2009 (RBE No.219/09) as detailed below:

For re-engagement in PB-2 with grade pay 4800/-	₹ 565/- per day
For re-engagement in PB-2 with grade pay 4200/-	₹ 550/- per day
7. On Re-engagement of retired employees, the daily allowance (Remuneration per day) and Basic Pension should not exceed the last pay drawn.
8. The selection is subject to their being found suitable by the committee constituted for the Purpose.
9. Remuneration will be as per the Grade Pay to which the retired employees are re-engaged.
10. The Administration is at liberty to terminate the services of the re-engaged personnel in case their performance is found to be unsatisfactory without prior notice and they will not have the prescriptive right for continuity in service on daily wages beyond 62 years of age.
11. The re-engagement of retired employees will be terminated immediately on joining of selected candidates from Direct Recruitment Quota/Promotional Quota.
12. The Re-engaged retired railway employee may be posted at any station of Samastipur division as per administrative Requirement.
